AGREEMENT

THIS AGREEMENT is entered into this 5th day of May, 1988, by and between the City of Grand Junction, Colorado, "CITY", and VisionQuest National, Ltd., "VISIONQUEST:"

Recitals

- A. VisionQuest is desirous of utilizing property owned by City, commonly known as the "Blue Heron" property, "Property", for camping purposes in conjunction with the VisionQuest "Wagon Train."
- B. City requires VisionQuest to observe ceratin conditions in connection with such use.
- IT IS THEREFORE AGREED that VisionQuest is hereby authorized to use the Property as stated herein subject to the following conditions:
- 1. The period of use shall be May 7th and 8th, 1988.
- 2. VisionQuest for Itself, its agents, officers and invitees waives and foregoes any claim, cause of action or demand it may have against the City for injury to or destruction of assets of VisionQuest which may be lost, injured or destroyed as a result of the act of VisionQuest or any third person or corporation.
- 3. VisionQuest shall indemnify the City of Grand Junction and save it harmless from any and all claims or causes of action arising out of or in any way connected to VisionQuest's use, occupancy and operation of the Property.
- 4. At all times during the use of the Property, VisionQuest shall secure and maintain public liability and property damage insurance in an amount of not less than \$2,000,000.00 as to injuries to persons or property and death of persons. Such policy of insurance shall be delivered to the City Manager prior to occupancy or use of the Property and VisionQuest, prior to any use or occupancy of the Property, shall obtain the City Manager's approval thereof.
- 5. VisionQuest shall leave the Property in the same or better condition as existing, and shall remove all debris created in association with its use of the Property.
- 6. VisionQuest agrees that venue for any action arising out of its use of the City's Property shall be in Mesa County, Colorado.
- 7. The individual executing this agreement on behalf of VisionQuest agrees that such individual has the full power and authority to bind VisionQuest National, Ltd., and that in the event VisionQuest National, Ltd., is not bound to each and every term hereof, said individual shall be personally liable to the City of Grand Junction for each and every liability and promise made herein.

REQUEST FOR CONSTRUCTION OF A PARK, NEW ROAD WITH CURBS AND GUTTERS, AND AN AREA FOR CHILDREN TO WAIT FOR SCHOOL BUS AT FIRST & PATTERSON

Joan Raser, 3343 Northridge Drive, questioned the future use of the area at 1st and Patterson. Mrs. Raser understood that the City has refused to accept this particular property for future park use, and that the entrance to Willowbrook will be closed and a road will be constructed over Ranchman's Ditch into Northridge Drive. She asked the City to consider accepting the park property if the Northridge Homeowners Association would agree to maintain the park. There are approximately 100 homeowners in the area. She asked that a new road with curb and gutter, a park area, and a place for the children to catch the bus be constructed all at the same time.

Council President Bennett assured Mrs. Raser that Council will look into the offer and get back to her with an answer.

PROPOSED LOCATION OF NEW COUNTY JAIL

Councilman Nelson stated that the DDA has recently been contacted by Mike Kelly, head of the Mesa County Jail Site Committee, who will announce the relocation of the jail site in the near future. Presently, the Committee is considering a location in the County rather than inside the City limits of Grand Junction. encouraged a response from Council regarding its opinion.
