CITY OF GRAND JUNCTION, COLORADO MINUTE OF THE REGULAR MEETING OF THE CITY COUNCIL

October 19, 1988

The City Council of the City of Grand Junction, Colorado, convened in regular session the 19th day of October, 1988, at 7:30 p.m. in the City/County Auditorium at City Hall. Those present were LeRoy Kirkhart, Bill McCurry, Paul Nelson, O.F. Ragsdale, Reford Theobold, and President of the Council John Bennett. Councilman R.T. Mantlo was absent. Also present were City Manager Mark Achen, City Attorney Dan Wilson, and City Clerk Neva Lockhart.

Council President Bennett called the meeting to order and Councilman McCurry led in the Pledge of Allegiance.

There being no corrections or additions to the minutes of the October 5, 1988, they were approved as submitted.

HEARING #34-88 - UTILITY EASEMENT VACATION LOCATED AT 2415 APRICOT COURT - CONTINUED TO NOVEMBER 2, 1988, MEETING

A hearing was held after proper notice on the petition by Leo and Joyce Little for a utility easement vacation located at 2415 Apricot Court. Kirk Rider, attorney, was present representing Mr. and Mrs. Little. He stated that there are some extraneous issues regarding this petition. The garage on the house belonging to the Littles is in substantial violation of the setback requirements applicable throughout the City of Grand Junction, and actually intrudes into a utility easement that is owned by the City.

Mr. Rider stated that the Spring Valley Homeowners' Association, at its Board of Directors Meeting on October 13, 1988, agreed to express no position on the variance, and unanimously voted to express no objection to the easement vacation request. He admonished Council to address the easement vacation and approve it.

Upon motion by Councilman Ragsdale, seconded by Councilman Nelson and carried, the Mayor is to appoint a committee of three members of Council to physically inspect the said property as to the complaints that have been voiced here this evening, and that this matter be tabled for decision by Council to November 2, 1988.

The President declared a five-minutes recess. Upon reconvening, six members of Council were present.

A hearing was held after proper notice on the petition by Gaynell Lenderman to vacate the alley between Grand Avenue and White Avenue, west of North First Street. There were no letters, opponents, or counterpetitions.

Councilman McCurry and carried, the proposed ordinance was passed for publication.

HEARING #35-88 - PROPOSED ORDINANCE - REZONE FROM RMF-32 TO PB PROPERTY LOCATED AT 704 ELM AVENUE, AND HOMETOWN REALTY FINAL PLAN

A hearing was held after proper notice on the petition by Virginia Edwards to rezone property located at 704 Elm Avenue from RMF-32 to PB, and Hometown Realty Final Plan. There were no letters, opponents, or counterpetitions. Upon motion by Councilman Theobold, seconded by Councilman Nelson and carried, the final plan for Hometown Realty at 704 Elm Avenue was approved.

The following entitled proposed ordinance was presented and read: REZONING FROM RMF-32 TO PB THE PROPERTY LOCATED AT 704 ELM STREET AND LEGALLY DESCRIBED AS THE SOUTH 70.5 FEET OF LOT 1 OF ELM AVENUE SUBDIVISION OF LOT 14 OF CAPITAL HILL SUBDIVISION, EXCEPT THE SOUTH FOUR FEET, CITY OF GRAND JUNCTION, CITY OF GRAND JUNCTION, MESA COUNTY, COLORADO. Upon motion by Councilman Ragsdale, seconded by Councilman Nelson and carried, the proposed ordinance was passed for publication.

HEARING #37-88 - PROPOSED ORDINANCE - REZONE FROM C-2 TO RMF-64 PROPERTY LOCATED AT 125 OURAY AKA 127 OURAY AVENUE

A hearing was held after proper notice on the petition by James L. and Kraig S. Keltner to rezone from C-2 (Heavy Commercial) to RMF-64 (Residential Multi-Family) on .11 acres located at 125 Ouray also known as 127 Ouray Avenue.

Upon motion by Councilman Nelson, seconded by Councilman Ragsdale and carried, the proposed ordinance was passed for publication.

HEARING #3-88 - PROPOSED ORDINANCE - TEXT AMENDMENTS TO THE GRAND JUNCTION ZONING AND DEVELOPMENT CODE

A hearing was held after proper notice on the petition by the Grand Junction Planning Department for Text Amendments to the Grand Junction Zoning and Development Code. There were no letters, opponents, or counterpetitions.

The following entitled proposed ordinance was presented and read: AMENDMENTS TO THE CITY ZONING AND DEVELOPMENT CODE: A. REGARDING PLANNED DEVELOPMENT DESIGNATION ON THE OFFICIAL ZONING MAP, AND REQUIRING THAT ALL USES BEING CONSIDERED FOR A P.D. BE LISTED AND SUBMITTED ALONG WITH THE P.D. REQUEST; B. REGARDING LANDSCAPING REQUIREMENTS IN C-1 ZONES FOR FRONT YARD SETBACKS LESS THAN FIVE FEET; C. REQUIRING ALL PLATS TO IDENTIFY THE NAMES AND ADDRESSES OF ALL SURFACE OWNERS, MINERAL OWNERS, AND LESSEES OF MINERAL

OWNERS. Upon motion by Councilman Theobold, seconded by Councilman Kirkhart and carried, the proposed ordinance was passed for publication.

AMENDING CHAPTER 19-29 OF THE CODE OF ORDINANCES PERMITTING CONSUMPTION OF 3.2% BEER IN PUBLIC PARKS, PUBLIC RIGHTS-OF-WAY, OR OTHER PUBLIC AREAS - REMOVED FROM AGENDA

DECLARING THE NECESSITY TO TAKE PRIVATE PROPERTY BY EMINENT DOMAIN; SAID PROPERTY DESCRIBED AS LOTS 20, 21 AND 22 IN BLOCK 100 OF THE CITY OF GRAND JUNCTION, AND LOTS 23 AND 24 IN BLOCK 100 OF THE CITY OF GRAND JUNCTION, WITH STREET ADDRESS OF 118 MAIN STREET - TABLED TO NOVEMBER 2, 1988, CITY COUNCIL MEETING

NOW, THEREFORE, BE IT RESOLVED, the City of Grand Junction hereby approves the terms of contract L-08-89 and hereby authorizes the Mayor to sign the LEAF contract on behalf of the City of Grand Junction.
