Upon motion by Councilman Theobold, seconded by Councilman Kirkhart and carried, the President of the Council was authorized to sign State Contract EIAF No. 2104.

## CML EXECUTIVE BOARD MEETING

Councilman Theobold attended a CML Executive Board meeting discussing legislative proposals. One bill which appears to be well on its way to passage is H.B. 1092 which extends governmental immunity to privately owned property that is being leased by the government and that would include property such as the easements that the Riverfront Commission is obtaining from private property owners along the river. He noted that one of the difficulties in

getting some of these easements has been the question, if something should happen on one of these properties, the property owner is reluctant to have the public at large on his property for fear that he might get sued. This bill will greatly simplify that and help the City.
