inches above the grade of the ground in those areas as set forth in Section 5-3-2 of the City of Grand Junction Zoning and Development Code; the petitioners will not hold the City liable for any damages caused to said landscaping improvements as a result of the City's maintenance or future installation of roadway improvements or public utilities within the aforedescribed public right-of-way; and that said Revocable Permit shall be issued only upon the concurrent execution by the petitioners of an agreement that the petitioners will save and hold the City, its officers, employees and agents harmless from, and indemnify the City, its officers, employees and agents, any claims or causes of action however stated rising out of the encroachment or use granted, and that upon revocation of such permit, the petitioners will, within thirty (30) days of notice of revocation, peaceably surrender said right-of-way to the City and, at their own expense, remove any encroachment so as to restore the right-of-way to its original condition.

Hooker and Total Petroleum Inc. a Revocable Permit to allow the use of the public right-of-way described above for the purposes described above; provided, however, that the petitioners shall not permit shrubs, plants or any other item to grow to a height exceeding thirty (30) inches above the grade of the ground in those areas as set forth in Section 5-3-2 of the City of Grand Junction Zoning and Development Code; the petitioners will not hold the City liable for any damages caused to said landscaping improvements as a result of the City's maintenance or future installation of roadway improvements or public utilities within the aforedescribed public right-of-way; and that said Revocable Permit shall be issued only upon the concurrent execution by the petitioners of an agreement that the petitioners will save and hold the City, its officers, employees and agents harmless from, and indemnify the City, its officers, employees and agents, any claims or causes of action however stated arising out of the encroachment or use granted, and that upon revocation of such permit, the petitioners will, within thirty (30) days of notice of revocation, peaceably surrender said right-of-way to the City and, at their own expense, remove any encroachment so as to restore the right-of-way to its original condition.
