GUN LEGISLATION

Mr. Kaufman was concerned that a group called Handguns Control, Inc., could possibly approach Council and give misinformation regarding this issue.

HEARING #47-89 - REQUEST TO DEFER OPEN SPACE FEE AT 2464 F ROAD FOR LIL' SPROUT NURSERY

A hearing was held after proper notice on the application by Cody Purser to defer the open space fee at 2464 F Road for Lil' Sprout Nursery. This item was continued from the October 18, 1989, City Council meeting. Planner Kathy Portner reviewed the request stating that the petitioner has requested that the \$1250 Parks and Open Space Fee be deferred with payments beginning in the Fall of 1990. This request was denied by the Planning Commission with the intent that City Council make a decision on this particular type of financing.

Cody Purser, petitioner aged 19, was out of State acquiring additional information for the nursery. Keith Purser, father of Cody Purser, was present to answer questions of Council.

Upon motion by Councilman Ragsdale, seconded by Councilman Shepherd and carried, the \$1250 open space fee was deferred with payments commencing September 1, 1990, at 12% interest in 24 monthly payments with Keith Purser as co-signer until paid in full.

City Attorney Wilson noted that the reason Council is willing to accommodate Mr. Purser is the age of the petitioner and the willingness to take a risk at the age of 19, and that type of business. He confirmed that this is an exceptional set of circumstances, and not to be construed as a basis for others to make the same request. It was clarified that the request is to defer the payment and not waive the payment.
