GRAND JUNCTION MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL

AUGUST 5, 1992

The City Council of the City of Grand Junction, Colorado, convened in regular session the 5th day of August, 1992, at 7:30 p.m. in the City/County Auditorium at City Hall. Those present were Jim Baughman, John Bennett, Bill Bessinger, Bill McCurry, Conner Shepherd, and President of the Council Reford Theobold. Councilman Paul Nelson was absent. Also present were City Manager Mark Achen, City Attorney Dan Wilson, and Acting City Clerk Teddy Martinez.

Council President Theobold called the meeting to order and Councilman Bennett led in the Pledge of Allegiance. The audience remained standing during the invocation by Rev. Herb Ortman, First Church of God.

CONSENT ITEMS

Upon motion by Councilman McCurry, seconded by Councilman Bessinger and carried, the following Consent Items 1-3 were approved:

1. Approve the minutes of the Regular Meeting July 15, 1992

2. Authorization to purchase a 5-yard Dump Truck for the Streets Division from Western Slope Ford for \$43,078

Bids were opened July 15th for the purchase of a 5-yard Dump Truck for the Streets Division. Invitation for Bids were sent to seven (7) dealers; five (5) bids were received. The low responsive bid of \$43,078 was submitted by Western Slope Ford.

3. Authorization to contract with WD Yards for the labor and material to install sprinkler systems at the Municipal Cemetery and Sherwood Park. Total cost for both areas is \$88,414.68

Bids were opened July 14th for labor and materials to install sprinkler systems at the Municipal Cemetery and Sherwood Park. Specifications and drawings were distributed to eight (8) contractors; four (4) bids were received. The low bid was submitted by WD Yards in the amount of \$39,451.62 for the cemetery and \$48,963.06 for Sherwood Park.

HEARING - APPLICATION BY MESA COUNTY PARTNERS FOUNDATION FOR A MALT, VINOUS AND SPIRITUOUS LIQUOR SPECIAL EVENTS PERMIT ON SATURDAY, AUGUST 22, 1992, FROM 12:00 NOON TO 12:00 MIDNIGHT, AT WALKER FIELD AIRPORT, FOR A FUND RAISING BANQUET

A hearing was held after proper notice on the application by Mesa County Partners Foundation for a Malt, Vinous and Spirituous Liquor Special Events Permit on Saturday, August 22, 1992, from 12:00 noon to 12:00 midnight, at Walker Field Airport, for a fund raising banquet. Mr. Jeff Wendland, Airport Manager and President of the Mesa County Partners Foundation, was present. There were no opponents, letters or counterpetitions. Upon motion by Councilman McCurry, seconded by Councilman Shepherd and carried, the application was approved.

PUBLIC HEARING - P & F ANNEXATION LOCATED WEST OF SOUTH CAMP ROAD AND NORTH OF THE COLORADO NATIONAL MONUMENT - RESOLUTION NO. 53-92 TO ANNEX BY ORDINANCE - PROPOSED ORDINANCE - TABLED TO AUGUST 19 MEETING

Karl Metzner, Community Development Department, reviewed this item.

It was moved by Councilman Shepherd and seconded by Councilman Bessinger that Resolution No. 53-92 be passed and adopted.

Dr. William Patterson, petitioner, was present and requested that his petition be withdrawn. He has been extensively lobbied since he filed his petition. He would like more time to consider the petition, and consider refiling at a later date.

President of the Council Theobold explained that legally the petition has been filed and accepted. Council can either defer the item, or vote NO on the item.

City Attorney Wilson stated that Council could allow Dr. Patterson to withdraw the petition, but if Council does not want him to withdraw, the process could proceed.

Councilman Shepherd explained that first reading of the ordinance does not require a hearing. After publication in the local newspaper, interested persons may testify at the hearing held on second reading. Passage of the ordinance for publication does not bind Dr. Patterson or the City into annexation. He encouraged Dr. Patterson to allow City Council to pass the proposed ordinance for publication to allow that forum by the public, which will also allow Dr. Patterson two weeks to make his decision.

Dr. Patterson preferred that he have time to do his homework properly, then make a decision and come back to Council in the future. Councilman Shepherd moved that his motion on this item be tabled to the August 19, 1992, City Council meeting. The motion passed with Council members BESSINGER and THEOBOLD voting NO.

PROPOSED ORDINANCE -- HI-FASHION FABRICS - REZONE FROM RSF-4 TO PB FOR LIGHT RETAIL IN A PLANNED BUSINESS ZONE AT THE NORTHWEST CORNER OF PATTERSON ROAD AND MEANDER DRIVE

Hi Fashion Fabrics currently located at First and Orchard applied for a zone change and final plan/plat for a 2 lot subdivision at the northwest corner of Patterson Road and Meander Drive. One lot currently contains a single family residence and would remain RSF-4. The other lot is requested for planned business zoning to allow the construction of a new fabric store. The adopted Patterson Road Guidelines currently recommend low volume business uses on the north side of Patterson between 25-1/2 Road and First Street. Access to the business would be from Meander Drive. Karl Metzner, Community Development Department, reviewed this item. Planning Commission recommends approval of the rezone.

Upon motion by Councilman Baughman, seconded by Councilman Bennett and carried, the proposed ordinance was passed for publication.

ACCEPTING A PETITION FOR THE ANNEXATION OF LANDS TO THE CITY OF GRAND JUNCTION, COLORADO, AND SETTING A HEARING ON SUCH ANNEXATION BELLA VISTA #2 ANNEXATION - APPROXIMATELY 24.0 ACRES LOCATED NORTH OF G ROAD AND WEST OF 27 ROAD

WHEREAS, on the fifth day of August, 1992, a petition was submitted to the City Council of the City of Grand Junction, Colorado, for annexation to said City of the following property situate in Mesa County, Colorado, and described as follows:

W ALONG THE EAST LINE OF THE SE1/4 SE1/4 OF SAID SECTION 35 A DISTANCE OF 684.40 FEET TO A POINT ON THE SOUTH RIGHT-OF-WAY OF KIMBERLY DRIVE, AS EXTENDED; THENCE N 89 DEG. 58 MIN. W ALONG SAID RIGHT-OF-WAY A DISTANCE OF 637.65 FEET TO THE NORTHWEST CORNER OF LOT 4, BLOCK 3, OF THE FIRST ADDITION TO BELLA VISTA SUBDIVISION; THENCE CONTINUING ALONG SAID RIGHT-OF-WAY WEST A DISTANCE OF 403.40 FEET TO A POINT OF CURVATURE; THENCE 55.04 FEET ALONG THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS OF 35.0 FEET, A CENTRAL ANGLE OF 90 DEG. 06 MIN., AND A LONG CHORD WHICH BEARS S 45 DEG. 03 MIN. That a hearing will be held on the 16th day of September, 1992, in the City-County Auditorium in City Hall of the City of Grand Junction, Colorado, at 7:30 o'clock p.m. to determine whether onesixth of the perimeter of the area proposed to be annexed is contiguous with the City; whether a community of interest exists between the territory and the City; whether the territory proposed to be annexed is urban or will be urbanized in the near future; whether the territory is integrated or is capable of being integrated with said City; whether any land in single ownership has been divided by the proposed annexation; whether any land held in identical ownership comprising more than twenty acres which, together with the buildings and improvements thereon, has an assessed valuation in excess of two hundred thousand dollars is included without the landowner's consent; whether any of the land is now subject to other annexation proceedings; and whether an election is required under the Municipal Annexation Act of 1965.

ACCEPTING A PETITION FOR THE ANNEXATION OF LANDS TO THE CITY OF GRAND JUNCTION, COLORADO, AND SETTING A HEARING ON SUCH ANNEXATION ROUND HILL ANNEXATION - APPROXIMATELY 39.48 ACRES LOCATED NORTH OF HORIZON DRIVE AND EAST OF 7TH STREET

WHEREAS, on the fifth day of August, 1992, a petition was submitted to the City Council of the City of Grand Junction, Colorado, for annexation to said City of the following property situate in Mesa County, Colorado, and described as follows:

Commencing at the Center of Section 2, Township 1 South, Range 1 West of the Ute Meridian, Mesa County, Colorado, and considering the line between the Center of said Section 2 and the Northwest corner of the SW1/4 NE1/4 of said Section 2 to bear North 00 deg. 00 min. 00 sec. East with all bearings contained herein being relative thereto; thence North 89 deg. 51 min.
