A. National/Alamo Release Item: Resolution 2009-005

WSR (a local rental car franchisee) sold its National/Alamo rental car franchise to Vanguard Car Rental. Enterprise Rent-A-Car owns Vanguard Car Rental. Vanguard Car Rental is the parent company for the National/Alamo rental car chain. WSR has requested to assign all its rights under that certain Airport Facilities Lease and Rental Car Concession Agreement between the Authority and WSR be released to Vanguard Car Rental. Commissioner LaCroix moved to approve the National/Alamo Release.
