RE: Tobacco Ordinance Tickets

Between the dates of September 1, 1999 and May 31, 2000, 177 tobacco ordinance tickets were written. (Please note: in the memo from Lt. Nordine, he indicates that 172 tickets were written. His count started on September 7, rather than September 1.) Of that number:

139 pled guilty

4 were found guilty at trial

34 have either not been to court or did not appear in court on the scheduled date

Of those juveniles who did not appear, or who failed to pay a fine or attend tobacco class, a warrant is issued.

Additionally,

99 persons received one ticket

20 persons received two tickets

7 people received three tickets

3 people received four tickets

The majority of the tickets have been written at Grand Junction High School, as this is the only high school within city limits. The rest of the cases have either been at the middle schools, or in conjunction with some other police contact (such as a traffic stop).

After the class 40.8 percent say they will try to quit.

Out of 152 participants 62 or 40.8 percent indicated they were either going to quit or "try" to quit; 25 or 16.5 percent indicated they were going to "cut back;" 44 or 29 percent said they would continue smoking; and 6 or .04 percent said they didn't know what they would do. Two participants had already quit, one was cited for possession and was not a smoker, one indicated they had never been a smoker and some did not answer the question.

Non-ticketed youth attend class.

In February four students attended the class that were not cited for possession. When asked why they wanted to come to the class, they said they were there to support their friends. They all participated in the class as though they had been ticketed.

Subject: Ballot question to remove the general government revenue limitation imposed by Article X, Section 20 of the Colorado Constitution, without any increase in taxes or tax rates.

Summary: On June 19, 2000 the City Council began discussing the possibility of going to the voters of Grand Junction to ask for a waiver of the revenue limitations of the Tabor amendment. This subject was also discussed in memorandums of May 31, 2000 and June 27, 2000. The staff recommends that the question be presented at either the upcoming November election or our regular local election in April 2001, and that the revenues be dedicated to the additionally needed capital improvements. We would be irresponsible if we did not ask our voters if we should retain these resources and accomplish the capital improvements needed.

Background Information: In November, 1992 the voters of the State of Colorado approved Article X, Section 20 of the Colorado Constitution, which besides restricting the imposition of new taxes, limited the revenues currently being generated by state and in our case local tax rates. Although we monitored since 1992 our allowed growth rates and overall government revenues this new law had no real impact on the City of Grand Junction until 1999. Beginning last year and probably for the foreseeable future, we will be restricted from keeping and using the revenues, mostly from Sales and Use Taxes, that are needed for important infrastructure and facility needs of the community. Now that we have hit the limit the overage is expected to grow rapidly and permanently in the years ahead.

Approval for the City to retain Tabor Excess Revenues is very important because:

1. We would be asking to retain revenues generated from the current tax rates, not increase taxes. We certainly would be keeping the spirit of Tabor, i.e. "No new taxes without a vote".

- Our growth in capital needs and City services is not in step with the Denver/Boulder CPI In fact, our growth is greater, our inflation is greater, and our communities needs are greater than diverse metro areas of the state.
 The longer we wait to do this the worse the situation is going to become.

4. We should ask for a permanent exemption like many of our neighboring communities and District #51; so that future City Councils and citizens will not have this time bomb facing them again in the future.

Budget: The final audited excess revenue in 1999 is approximately \$600,000. We have estimated \$3.2 million in 2005, \$10.4 million by 2010, and \$23.3 million by 2015.

Action Requested/Recommendation: I recommend that the City Council of the City of Grand Junction adopt Proposed Ballot Question 1 on the attached. It would remove all general government revenues from the revenue limitation with the exception of property taxes (growth of which would continue to be restricted). These property tax restrictions are estimated to cause approximately \$25 million in tax reductions or refunds over the next fifteen years alone. Over the years that I have been in Grand Junction our City Councils have confirmed their own voluntary restrictions on the growth of property taxes on many occasions.

I believe the City Council should give serious consideration to also placing a debt authorization measure on the ballot, such as Proposed Ballot Question 3 on the attached. Without this important tool the expectations and needs of the community can not be met for many years to come. The net cost to the City and its taxpayers by borrowing and building facilities now is very reasonable in light of the resulting early community use.

Proposed Ballot Question

- 1. Shall the City of Grand Junction, Colorado, without any increase in tax rates (unless voter approved), be authorized to collect, retain and expend the full proceeds from (i) Grant Funds, (ii) Interest earnings on investments, (iii) Development Fees, (iv) All state shared revenues and taxes, (v) Sales and use taxes collected at existing rates and, (vi) All other non-tax revenue sources, to be spent on capital projects or other basic city governmental services notwithstanding any restriction of Article X, Section 20 of the Colorado Constitution for 1999, 2000 and subsequent years?
- 2. Shall the City of Grand Junction, Colorado increase it's sales & use tax rate by 1/8% (0.125%) effective January 1, 2001 and for fifteen years thereafter until December 31, 2015 for use in constructing and operating Parks and Recreation facilities?
- 3. Shall the City of Grand Junction, Colorado be authorized to issue full faith and credit General Obligation Bonds from time to time for capital construction projects up to a maximum amount of \$90 million over the next 15 years until December 31, 2015?
