#### Dear City Council Members:

The City Youth Council has made what I feel to be significant progress this month. The Wal-Mart grant that the youth council chose two programs to receive have since been given the information for their grant and will be able to use it soon. Additionally, the Organizational Outreach Committee has taken the responsibility of giving support to the Youth School Board that has been established within District 51. This board is intended to act for the School Board in a similar capacity to that which the youth council does for the City Council. We feel this is a worthwhile program and one that must be continued.

Colorado Close Up was a great experience for all four members who attended. The four of us experienced a mock Supreme Court trial, attended lectures from various state representatives and senators, heard from lobbyists, and witnessed the House and Senate in action. We have already begun to relate our experience to the rest of the council. Much of the final meeting in February consisted of relaying information to the council about the channels that need to be used in order to have the youth council opinions heard. Additionally, we decided that the Legislative Committee is to meet each Monday at the public library in order to discuss legislation we feel the youth council may want to either support or oppose.

The survey committee has also been meeting to develop a survey that may be dispersed amongst teens. It will include items such as what teens feel the Valley needs, what their opinion of the Youth Council's actions thus far are, and many other pertinent questions. We have much of the survey constructed, but no final decisions have as yet been made.
