

Here is what happened in liquor licensing in 2014

There were 11 new applications:

- 6—Hotel/Restaurants
- 2—Taverns
- 1—Beer and Wine
- 2—3.2% Beer Retail (Off Premises)



The City hosted six Alcohol Server Responsibility Training session and there were three special sessions held for a total number of 447 attendees.

Liquor License Renewals

The State Liquor Enforcement Division mails out liquor license renewals approximately 90 days before the license expires. The renewal form and State and City Fees must be submitted to the Local Licensing Authority (City Clerk's Office) at least 45 days prior to the expiration date of the liquor license. If you have not received your renewal application from the State, you can access the State Liquor Enforcement Division's website at https://www.colorado.gov/pacific/enforcement/liquor-tobacco-forms, download Form DR 8400 – Renewal Application for Liquor & 3.2% Beer License, complete it, and submit it to the City Clerk's Office with the appropriate fees.

OCCUPATIONAL TAX

Annual notices were mailed on December 3, 2014 for the 2015 Occupational Tax that is due January 1st of each year. A big thanks to all of the establishments that have already paid the tax due. If you did not receive your notice, please call the City Clerk's Office at (970) 244-1510. Unpaid Occupational Tax will become delinquent on February 1, 2015. Establishments who have not paid the tax by February 1, 2015 will be subject to interest on the tax. Interest shall accrue on all delinquent taxes from the day of delinquency until paid or collected, at the rate of 1% per month. Late notices will be sent out to establishments on February 2, 2015 and will show a 1% interest

assessment.

Colorado Liquor Enforcement Emergency Rule - Fee Reduction

On December 18, 2014, the State Licensing Authority adopted an Emergency Rule for the reduction of Liquor License application fees to be effective January 1, 2015.

The fee reduction is as follows:

\$600 - New license application

\$600 - License transfer

\$700 - New license application with concurrent review

The reduction in application fees is temporarily being implemented to bring the Liquor Enforcement Divisions cash reserve into compliance with state law. The Division anticipates the fees to be increased once the cash reserve meets the statutory amount.

Application fees due to the City remain unchanged.
