Item 2: Approve Minutes

The Forestry Advisory Board agreed that class "C" should be renamed to "Landscape Maintenance / Ground Tree Maintenance; for those in the lawn care, nursery or landscape business. This class will be

allowed to prune and trim trees if elevations off the ground is not required. Must pass the Class "C" test."
