Ordinance No 129

An Ordinance to Amend Ordinance No 114 entitled "an Ordinance to amend Section one of Ordinance No. 6, being an Ordinance entitled an Ordinance Concerning the Fire Limits, passed and adopted February 10 a. d. 1903.

Be it ordained by the City Council of the City of Grand Junction, Colorado:

Section I

That Ordinance No. 114 entitled "an Ordinance to amend Section I of Ordinance No. 6, being an Ordinance entitled An Ordinance Concerning the Fire Limits, be and the same is hereby amended so as to read as follows:

That section I of Ordinance No. 6, entitled An Ordinance Concerning the Fire Limits, be and the same is hereby amended so as to read as follows:

Section I

All that portion of the City of Grand Junction embraced within the following described limits shall be known as the fire limits of the City of Grand Junction and subject to the provisions contained in Ordinance No. 6, of the Ordinances of this City. Namely: Commencing at the north west corner of Block one hundred (100) at the intersection of Road Avenue and First Street; running thence east along the south side of Road Avenue to its intersection with Seventh Street; thence south along the west side of Seventh Street to its intersection with Colorado Avenue; thence west along the north side of Colorado Avenue to the south east corner of Block one hundred fifteen (115); thence south along the west side of Sixth Street to its intersection with the alley running through Block one hundred and twenty two (122) thence west along the north side of Sixth (12) in Block one hundred and twenty three (123) thence south along the west side of Third Street to the south east corner of Block one hundred and forty five (145) thence west along the south side of said Block one hundred forty five (145) to the property line of the Denver and Rio Grande Railroad Company

Section II

thence North westerly along said property line to its intersection with the east line of First Street; thence north to the place of beginning.

This Ordinance shall be known and numbered as Ordinance No. 129.
