

Ordinance No. 143.

An Ordinance establishing the Compensation and Salaries of City Officers.

Be it Ordained by the City Council of the City of Grand Junction, Colorado.

Section I.

From and after the passage of this Ordinance the salaries of the Officers of the City of Grand Junction shall be as follows.

- 1st, -- The Mayor, \$30.00 per month payable monthly.
- 2nd, -- City Clerk, \$50.00 from Salary Fund and \$50.00 from Water Fund per month, Payable monthly.
- 3rd, -- City Treasurer, \$30.00 per month payable monthly.
- 4th, -- City Marshal, \$90.00 per month payable monthly.
- 5th, -- City Attorney, \$60.00 per month payable monthly, and also a fee of \$5.00 per case argued against the defendant in each case of collected.
- 6th, -- City Street Commissioner \$90.00 per month payable monthly.
- 7th, -- Superintendent of Water Works \$125.00 per month payable monthly.
- 8th, -- Chief of Fire Department \$75.00 per month payable monthly, The First Assistant Chief of Fire Department, \$70.00 per month payable monthly, The second assistant Chief of Fire Department \$60.00 per month payable monthly.
- 9th, -- Alderman, each \$10.00 per month payable monthly.
- 10th, -- City Physician \$20.00 per month payable monthly.
- 11th, -- Police Magistrate \$10.00 per month payable monthly, and also such fees as are provided by law for Justices of the Peace in Mesa County for like services, provided the City shall not be liable for any fees.

Section II.

All Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed.
