The Board convened at 10:30 am at the Redlands Community Club. Guests and Harry Graff, new Board member from the Downtown Development Authority, were introduced.

What's going on in other communities and where can Grand Junction go from here? Presenter: Jon Schler, Colorado Center for Community Development

Jon Schler presented an overview of Historic Preservation in Colorado including activities of the Colorado Historical Society (CHS), Colorado Preservation, Inc. (CPI), Colorado Community Revitalization Association (CCRA) and the National Trust for Historic Preservation (NTHP) that has a regional office in Denver. The ideas and projects summarized throughout the state included:

- Green and Sustainability
- Demolition Delay Provisions and Review of every demolition permit
- Design assistance for historic buildings
- Secondary building, Post-WWII and cemetery surveys
- Façade fix-up programs
- Web sites, use of technology, development of oral histories
- Red Mountain Project
- Hands-On Restoration Classes
- Reuse Feasibility Studies
- Public/Private Partnerships to renovate/restore/resell historic buildings
- Heritage Tourism Program

Jon also briefly discussed the Certified Local Government (CLG) Program. There are small grants available through the program that can be used to leverage larger grants through NTHP or CHS. CLG is a means of bringing a collective voice regarding historic preservation in a community. The Board discussed having Dan Corson, the CHS CLG liaison visit and speak in greater detail about the certification process. The potential for CLG status, particularly addressing the original square mile, should be included in the Downtown Plan that is currently being developed.

History Overview and Tour of Redlands Club

Presenter: Clara Ziegler, Redlands Women's Club

Clara Ziegler gave an interesting and lively presentation to the Board about the history of the Redlands Community Center, its ownership and its current state of renovation. Colorado Historical Society grants have been used in the past to assist with the restoration of the windows, exterior and the main interior meeting room. The restrooms in the building are need of modernization to bring them up to ADA compliance but grant funds cannot be used for the work. The Center is currently raising funds for that project.
