Ordinance #161

An Ordinance to amend the third and fourth subdivisions of Sec. 1 of Ordinance #69 passed Feb. 9<sup>th</sup> 1891, entitled "An Ordinance concerning Licenses", and repealing Sec. 1 of Ordinance #8 passed and adopted Sept. 26<sup>th</sup> 1891; also repealing Ordinance #25 passed Sept. 26<sup>th</sup> 1892, also repealing Ordinance #47 passed July 9<sup>th</sup> 1895; also Ordinance #63 passed Aug. 12<sup>th</sup> 1897.

Sec. 1

Be it ordained by the City Council of the city of Grand Junction:  
That the third and fourth subdivisions of Section 1 of Ordinance No. 69 passed Feb. 9<sup>th</sup> 1891 entitled "An Ordinance concerning licenses and repealing Ordinance No. 8 passed and adopted Sept. 26<sup>th</sup> 1891; also repealing Ordinance No. 25 passed Sept. 26<sup>th</sup> 1892; also repealing Ordinance No. 47 passed July 9<sup>th</sup> 1895; also Ordinance No. 63 passed Aug. 12<sup>th</sup> 1897, be and they hereby are amended to read as follows:

3<sup>rd</sup> - Peddlars with one horse and wagon, Two (\$2<sup>00</sup>) dollars per day or three hundred (\$300<sup>00</sup>) dollars per year.

4<sup>th</sup> - Peddlars with two horse wagon two and one half (\$2<sup>50</sup>) dollars per day or three hundred (\$300<sup>00</sup>) dollars per year.

Passed and adopted by the City Council of the City of Grand Junction this 8<sup>th</sup> day of June A.D. 1909.
