An Ordinance creating Sanitary Sewer District Number 344 of the City of Grand Junction.

Be it Ordained by the City Council of the City of Grand Junction:

Sec. 1 That Sanitary Sewer District #3 of the City of Grand Junction be, and the same is, hereby created, consisting of all that portion of the said City of Grand Junction situate, lying and being within the following described boundaries, to-wit: Beginning at the corner of Twelfth Street and Grand Avenue, the same being the N.W. Cor. of Block A, Keith's Addition; running thence east along Grand Avenue to the northeast corner of Block C, Keith's Addition; thence south to the southeast corner of Block X, Keith's Addition; thence west to the intersection of Ninth Street with the city limits, being the Southwest corner of Block 157 of the City of Grand Junction; thence north along Ninth Street to its intersection with Ute Avenue, being the Northwest corner of Block 135 of the City of Grand Junction; thence East along Ute Avenue to Twelfth Street, the same being the Northwest corner of Block P, Keith's Addition; thence North along Twelfth Street to the point of place of beginning.

Sec. 11 That Sanitary Sewer District #4 of the said City of Grand Junction be, and the same is, hereby created, consisting of all that portion of the said City of Grand Junction situate, lying and being within the following described boundaries, to-wit: Beginning at the corner of Eighth Street and North Avenue, the same being the Northwest corner of Block 4 of the City of Grand Junction; thence running East along North Avenue to its intersection with Twelfth Street, the same being the Northeast corner of Block 1 of the City of Grand Junction; thence south along Twelfth Street to its intersection with Chipeta Avenue, the same being the Southeast corner of Block 45 of the City of Grand Junction; thence west along Chipeta

Avenue to its intersection with Ninth Street, the same being the Southwest corner of Block 47 of the City of Grand Junction; thence west along Ninth Street to its intersection with Hill Avenue, the same being the Southwest corner of Block 25 of the City of Grand Junction; thence west along Hill Avenue to its intersection with Eighth Street, the same being the Southwest corner of Block 26 of the City of Grand Junction; thence west along Eighth Street to the place of beginning.
