. ORDINANCE NO. 184.

THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION,

COLORADO, PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE

CITY OF GRAND JUNCTION FOR THE PISCAL YEAR BEGINNING JANUARY

1st, A. D. 1911, AND ENDING DECEMBER 31st, A. D. 1911.

Be it Ordained by the City Council of the City of Grand Junction, Colorado:

Section 1. That the following sums of money, or so much thereof as may be necessary, be and the same are hereby appropriated for the purposes of defraying the necessary expenses and liabilities of the City of Grand Junction, Colorado, for the fiscal year beginning January 1st, A. D. 1911, and ending December 31st, 1911, to-wit:

Section 2. That for the purpose of defraying the necessary expenses and liabilities of the said City of Grand Junction for the said fiscal year, beginning January 1st, A. D. 1911, and ending December 31st, A. D. 1911, there shall be and hereby is levied and assessed upon all the taxable property situated within the corporate limits of said City of Grand Junction, both real and personal, the following amounts for special and general taxes, to-wit:

First. For the purpose of defraying the annual interest on outstanding water bonds, a special tax of three and three-fourths (3%) mills on each dollar of said property so assessed or to be assessed.

Second. For the purpose of defraying the expenses and maintenance of the free Public Library, a tax of three-fourths of one (of cf l) mill on each dollar of said property so assessed or to be assessed.

Third. For the purpose of defraying the necessary expenses and liabilities of said City of Grand Junction , a tax of twenty-two and one-half (221) mills is hereby assessed on each dollar of said property so assessed or to be assessed.
