

Ordinances of the City of Grand Junction, Colorado

ORDINANCE NO. 185.

AN ORDINANCE CONCERNING SALARIES OF CITY OFFICERS AND EMPLOYEES, AND FIXING THE AMOUNT OF THE BOND TO BE GIVEN BY EACH OFFICER AND EMPLOYEE.

Be it Ordained by the City Council of the City of Grand Junction, Colorado:

Section 1. The several officers and employes of the City shall receive the following monthly salaries, payable at the close of each and every month, viz.:

City Attorney	\$ 90.00
City Health Officer	40.00
Plumbing Inspector	100.00
Janitor at the City Hall	15.00

The City Surveyor shall receive no salary, but shall be allowed to charge and demand in advance the following fees from the owners of the property ordering the work to be done, or against whom the same is properly chargeable: For surveying any one lot, \$2.00; for surveying every additional lot at the same time, and owned by the same person, \$1.00; for furnishing street grade for each lot, \$2.00; for any work performed for the city pay shall be as follows: \$1.00 per hour for the first ten days; when ten days and not more than fifteen days in any one month, 80 cents per hour; when fifteen days to a full month, 70 cents per hour.

POLICE DEPARTMENT.

FIRE DEPARTMENT.

Fire Chief and ex-officio City Weigher	\$90.00
Assistant Fire Chief	75.00

Driver Auto Fire Wagon	75.00

WATER DEPARTMENT.

Chief Engineer at Pump House	\$100.00
Assistant Engineers at Pump House	85.00
Construction Repairer	90.00

Sec. 2. All fees of the City Attorney, the Judge of the Municipal Court, the Police and other officers of the city, (excepting only the City Engineer) shall be paid into the City Treasury and belong to the City.

Sec. 3. Each Commissioner and every officer and employe shall give a bond to the City of Grand Junction, with sureties to be approved by the City Council, in the penal sums hereinafter named, conditioned that they will well and faithfully perform the duties of their respective offices and that they will pay over all moneys and deliver all property in their custody belonging to the city. The penalties in the bonds required by this section shall be as follows:

Commissioner of Public Affairs, \$2,000.
Commissioner of Water and Sewers, \$2,000.
Commissioner of Finance and Supplies, \$15,000.
Commissioner of Highways, \$2,000.
Commissioner of Health and Civic Beauty, \$2,000.
City Attorney, \$500.
City Health Officer, \$500.
Plumbing Inspector, \$500.
City Surveyor, \$2,000.
Chief of Police, \$2,000.
Night Marshal and each Police, \$500.
Fire Chief and City Weigher, \$500.

Sec. 4. Any and all ordinances or parts of ordinances in conflict with the provisions hereof be and the same are hereby repealed.
