Ordinances of the City of Grand Junction, Colorado

ORDINANCE NO. 196.

AN ORDINANCE IN RELATION TO SPIRITOUS, VINOUS, MALT, FERMENTED, DISTILLED, ALCOHOLIC, OR ANY INTOXICATING LIQUOR.

Be it Ordained by the City Council of the City of Grand Junction, Colorado:

Section 1. It shall be unlawful for any club, society, fraternal association or other association of individuals, or any member thereof, or other person, to store, keep or possess in any room or rooms, in the city of Grand Junction, or within one mile of its outer boundaries, used or occupied by such club, society, fraternal association or other association of individuals, or in any room adjacent thereto, any spiritous, vinous, malt, fermented, distilled, alcoholic or any interviously described. malt, fermented, distilled, alcoholic or any intoxicating liquor.

Sec. 2. It shall be unlawful for any club, society, fraternal association or other association of individuals, to permit any spiritous, vinous, malt, fermented, distilled, alcoholic or any intoxicating liquor to be drunk in any room or rooms, in the city of Grand Junction, or within one mile of the puter boundary thereof, used or occupied by such club, society, fraternal association, or other association of individuals.

Sec. 3. It shall be unlawful for any club, society, fraternal association, or other association of imdividuals, to permit any member or other person to drink, sell, give away, keep or store any spiritous, vinous, malt, fermented, distilled, alcoholic or any intoxicating liquor in any room or rooms, within the city of Grand Junction, or within one mile of the outer boundary thereof, used or occupied by such club, society, fraternal association, or other association of individuals.

Sec. 4. Any persons violating any of the previsions of this ordinance, or any director, officer or manager of any club, society, fraternal association, or other association of individuals, violating the previsions of this ordinance, upon conviction thereof, shall be punished by a fine not exceeding \$200.00, or by imprisonment in the city jail not exceeding 90 days, or by both such fine and imprisonment.
