

# Ordinances of the City of Grand Junction, Colorado

## ORDINANCE NO. 197.

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NUMBER 185, ENTITLED "AN ORDINANCE CONCERNING SALARIES OF CITY OFFICERS AND EMPLOYEES AND FIXING THE AMOUNT OF BOND TO BE GIVEN BY EACH OFFICER AND EMPLOYEE," PASSED AND ADOPTED THE 7th DAY OF FEBRUARY, 1911.

Be it Ordained by the City Council of the City of Grand Junction:

That Section 1 of Ordinance 185, entitled, "An Ordinance Concerning Salaries of the City Officers and Employes, and Fixing the Amount of the Bond to be Given by Each Officer and Employee," passed and adopted the 7th day of February, 1911, be and the same is hereby amended so as to read as follows:

Section 1. The salaried employes of the City shall consist of the following named persons with the monthly salaries set opposite their names, said salaries to be payable at the close of each and every month:

The city surveyor shall receive no salary but shall be allowed to charge and demand in advance the following fees from the owners of the property ordering the work to be done, or against whom the same is properly chargeable:

For any work performed for the city, pay shall be as follows: \$1.00 per hour for the first ten days; when ten days and not more than 15 days in any one month, 80 cents per hour; when 15 days to a full month, 70 cents per hour.
