ORDINANCE NO. 215.

THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION, COLORADO, PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION, FOR THE FISCAL YEAR BEGINNING JANUARY FIRST, A. D. 1914, AND ENDING DECEMBER 31, A. D. 1914.

Be it Ordained by the City Council of the City of Grand Junction, Colorado:

Section 1. The following sums of money or so much thereof as may be necessary, be and the same are kereby appropriated for the purposes of defraying the necessary expenses and liabilities of the City of Grand Junction, Colorado, for the fiscal year beginning January 1, A. D. 1914, and ending December 31, A. D. 1914, to-wit:

For maintaining the Fire Department
For maintaining the Police Department
For lighting the Streets and Public Buildings
For maintaining and operating the City Water First: \$ 5,300.00 Second: Third: 8,200.00 Feurth: Works
For maintaining, improving and repairing

Streets and Alleys and Water for Irrigation 12, 900.00

Health Department 4,000.00 Fifth: For maintaining the Health Department . . . For improvement and care of the Public Parks For the maintenance of the Free Public Library 4,000.00 Sixth: Seventh: 2,300.00 2,000.00 Eighth: For salaries of City Officers and Employes For the General Fund 9,100.00 Ninth: Tenth: Twelfth: For interest on outstanding City Warrants
Twelfth: For special assessments in Paving Districts
Thirteenth: For interest on Water Bonds
Fourteenth: For maintenance and repairs City Sewers 1,000.00 29,850.00 500.00

Sec. 2. That for the purpose of defraying the necessary expenses and liabilities of the said City of Grand Junction, Colorade, for the fiscal year beginning January 1, 1914, and ending December 31, 1914, there shall be and hereby is levied and assessed upon all the taxable property situated within the corporate limits of the said City of Grand Junction, both real and personal, the following amounts for special and general taxes, to-wit:

lst. Fer the purpose of defraying the expenses and maintenance of the free Public Library, a tax of two-tenths of one mill on each dellar of said property so assessed or to be assessed.

2nd. For the purpose of purchasing the necessary real estate and constructing thereon a Fire House and City Jail, one mill.

3rd. For the purpose of defraying the necessary expenses and liabilities of the said City of Grand Junction, and for the payment of interest on outstanding bands, a tax of six and fifty-six hundredths mills on each dollar of said property so assessed or to be assessed.

4th. For the purpose of paying the interest on outstanding warrants and paying special assessments on local improvements, twenty-four one-hundredths of one mill on each dollar of said property so assessed or to be assessed.
