ORDINANCE NO. 225.

AN ORDINANCE CONCERNING THE CARETAKER AT THE KANNAH CREEK INTAKE AND THE FOREMAN OF CONSTRUCTION AND REPAIR OF THE CITY WATER AND SEWER SYSTEMS, AND FIXING THE SALARIES OF CERTAIN EMPLOYEES.

Be it Ordained by the City Council of the City of Grand Junction, Colorado:

Section 1. There is hereby created the position of care-taker at the Kannah Creek intake. The care-taker shall have supervision and charge of the dam, intake, and other property belonging to the City of Grand Junction on Kannah Creek. He shall patrol Kannah Creek in the vicinity of the dam and intake for the purpose of preventing the contamination of the waters of Kannah Creek. The care-taker shall be under the charge and supervision of the Commissioner of Water and Sewers.

Section 2. There is hereby created the position of foreman of construction and vrepair of the city water and sewer systems, whose duty shall be to supervise and make necessary repairs and to construct new additions to the city water and sewer systems. He shall be under the charge and supervision of the Commissioner of Water and Sewers.

Section 3. The persons appointed and acting as care-taker of the Kannah Creek intake and as foreman of construction and repair of the city water and sewer systems when this ordinance goes into effect shall hold said positions under the civil service of the City of Grand Junction without examination.

Section 4. The care-taker of the Kannah Creek intake shall be paid a salary of Sixty-five Dollars per month, and the foreman of construction and repair of the city water and sewer systems shall be paid a salary of One Hundred Dollars per month.

Section 5. The janitor of the City Hall shall be paid a salary of Twenty-five Dollars per month.
