## Ordinances of the City of Grand Junction, Colorado

## ORDINANCE NO. 230.

THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION, COLORADO,

PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION,

FOR THE FISCAL YEAR BEGINNING JANUARY FIRST, A. D. 1915, AND ENDING DECEM-

BER 31, A. D. 1915.

Be it Ordained by the City Council of the City of Grand Junction, Colorado:

Section 1. That the following sums of money or so much thereof as may be necessary, be and the same are hereby appropriated for the purpose of defraying the necessary expenses and liabilities of the City of Grand Junction, Colorado, for the fiscal year beginning January 1, A. D. 1915, and ending December 31, A. D. 1915, to-wit:

First: For maintaining the Fire Department	\$5,600.00
Second: For maintaining the Police Department	\$5,3000000
Second: For maintaining the rolling Dublic Buildings	\$8,300.00
Third: For lighting the Streets and Public Buildings	40,000,00
Fourth: For maintaining, repairing and operating the City Water	Am 000' 00

Sec. 2. That for the purpose of defraying the necessary expenses and liabilities of the said City of Grand Junction, Colorado, for the fiscal year beginning January 1, 1915, and ending December 31, 1915, there shall be and hereby is levied and assessed upon all the taxable property situated within the corporate limits of the City of Grand Junction, both real and personal, the following amounts for special and general taxes, to-wit:

1st. For the purpose of defraying the expenses and maintenance of the Free Public Library, a tax of two-tenths of one mill on each dollar of said property so assessed or to be assessed.

2nd. For the purpose of defraying the necessary expenses and liabilities of

2nd. For the purpose of defraying the necessary expenses and liabilities of the said City of Grand Junction, and for the payment of interest on outstanding bonds, a tax of seven mills on each dollar of said property so assessed or to be assessed.

3rd. For the purpose of paying the interest on and the redemption of outstanding City Warrants, and paying special assessments on local improvements, eightenths of one mill on each dollar of said property so assessed or to be assessed.
