- 2. Pre-Bid Meeting Attendance at this pre-bid meeting is mandatory for contractor's submitting bids to become the general contractor.
- 3. Project Description The Project generally consists of all labor, equipment and materials to construct the restroom facility to the Plans and Specifications.
- 4. Project Documents
  - a. City of Grand Junction Standard Contract Documents
  - b. Project Bid Documents
  - c. Construction plans
  - d. Prequalification

Plans and Bid Documents are available for review or download on the City's Public Works Engineering web page.

- 5. Bid submittal procedures
  - a. Complete Bid Form in ink, sign and attach Bid Bond
  - b. Deliver to City Clerk's office prior to bid time
  - c. Attendance at bid opening is optional
- 6. Insurance and bonding requirements
  - a. 5% bid bond
  - b. Performance and payment bonds (100%)
  - c. Insurance in General Conditions



- 7. Addenda Addendum No. 1 will be issued following the Prebid Meeting. It will include all notes and questions that are addressed at the Pre-Bid meeting as well as the attendance list. Addendum No. 1 shall also include the following:
  - Revise SC-8 The City has prepared the Mesa County Building Permit and has completed the Gamma Radiation Survey, City of Grand Junction Planning Clearance, Fire Department Clearance and the Cross Connection permit. Once the project has been awarded, the Contractor shall complete and submit the permit to the County.
- 8. Project specific issues
  - a. <u>Hours of Operations</u> The hours of operations for this Project are as follows:
    Monday Friday, 7:00 AM thru 5:00 PM
  - <u>Traffic Control</u> During construction the site will need to be secured utilizing 6' chain link fencing.
  - c. <u>Las Colonias Park Phase I</u> The restroom and shelter project will be constructed simultaneously with Phase I. The City requests that a representative of each company attend both preconstruction meetings to discuss scheduling. It shall be the responsibility of the Contractor of Phase I to make the water and sewer connection at the shelter.
  - d. <u>Utilities (Electrical)</u> Xcel Energy will install a transformer adjacent to the shelter along with street and parking lot lighting. Anticipated completion of the site electrical supply (transformer) is the end of March. The Contractor is responsible for temporary power as well as necessary supply prior to Xcel's completion of work.
  - e. <u>Bid Alternate Item</u> The Bid Alternate consists of LED lighting at the shelter. See Plan Sheet E1-2 for the alternate LED schedule.
  - f. <u>Construction Staging</u> Storage of equipment and materials shall be contained within the construction site unless otherwise approved by the project manager.



9. Site visit - Following Pre-bid if necessary.

- g. <u>Project Retainage</u> The amount to be retained from partial payments shall be five
  (5) percent of the total value of the work completed as determined from the cumulative requests for payment.
- h. Project Start Date Construction is scheduled to begin on Monday, March 16<sup>th</sup>.
