## MINUTES OF A SPECIAL MEETING of the WALKER FIELD AIRPORT BOARD Held April 12, 1965 at Grand Jct., Colo.

The meeting was called to order by Chairman Arthur J. Jens at 11:05 a.m. in the Court House Annex Room 203A, Grand Junction, Colorado with the following members present:

The minutes of the last meeting were approved as submitted.

Jack Treece of Sky Trail Advertising presented a letter to the Board pertaining to a request for placing of three litter containers in the Walker Field Terminal Building. After considerable discussion it was moved by Paul Heidel and seconded by Ray Meecham that the request be denied on the basis that other people pay rent for advertising on the airport grounds and this could set a precedent. Motion carried.

The airport manager felt it might be in order that a resolution be adopted in recognition of the service given to this area by Frontier Airline and United Airlines. It was moved by Ed McCormick and seconded by Paul Heidel that the following resolutions be spread on the minute record of Walker Field Airport Board. Motion carried unanimously.

A letter from Grand Valley Aircraft was presented to the Board. It was suggested that the airport manager answer the questions asked.

It was moved by Ray Meecham and seconded by Paul Heidel that the reimbursable agreement for relocating FAA Navaids at Walker Field be approved. Motion carried.
