#### Regular Board Meeting Called to Order

Chairman Bettelli called the meeting to order at 5:30 p.m. A quorum was present.

# Approval of Minutes Dated October 27, 1992

Director Ingvertsen moved that the minutes of the October 27, 1992 Board Meeting be approved as submitted; seconded by Director Jokerst. Unanimously carried.

## Rental Car Concessions

Director Croker stated that bid proposals were received from the following rental car operators: Avis, Budget (Challenger, Inc.), Hertz (Daren Cyphers), and National (Dana Motors, Inc.). He moved to instruct staff to execute the bids and to sign contracts with all four entities pursuant to the proposals; seconded by Director Leane. Brief discussion followed. Unanimously carried.

### Division of Aviation Grant Resolution

Director Croker presented this request for \$50,000 which will be submitted to the State of Colorado Division of Aviation if approved. He moved acceptance of the Grant Acceptance Resolution (Resolution No. 1992-003); seconded by Director Leane. A roll call vote carried the resolution unanimously.

budget was scheduled for December 15, 1992 (the regular Board meeting). A budget workshop for the Board was scheduled for December 8, 1992 at 4:30 p.m.

## Fees and Charges

Manager Wendland indicated that the current fees and charges schedule is being updated to accommodate the changes with the parking lot as they relate to ground transportation users.

# October Financial Statements

Director Croker stated that the October financial statements reflect that revenues are up over last year, as are enplanements. Retained earnings generated year-to-date are over \$150,000, and expenses are under budget. He moved to adopt and approve the October financial statements as presented; seconded by Director Leane. Unanimously carried.

A committee consisting of Director Croker and Director Jokerst was appointed by Chairman Bettelli to review and make recommendations to the Board regarding collection issues.

### Amendment 1

A general discussion was held regarding the recent passage of Amendment 1. It appears that the Airport Authority is an enterprise fund because it receives less than 10% of its revenues from state and local funding sources and is empowered to issue airport revenue bonds.
