I. CALL TO ORDER

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson.

II. APPLICATION TO RENEW LIQUOR AND BEER LICENSES

The application for renewal for Mighty Meng, LLC dba North Avenue Liquors was found to be in order and approved.

III. APPLICATION FOR A TASTING PERMIT

 Stoner Enterprises Ltd. dba Andy's Liquor Mart, 922 N. 1st Street, Grand Junction, CO 81501, Retail Liquor

Mr. William Hepworth, Wine Purchasing Manager, was present representing the applicant.

Ms. Peterson reported the paperwork is in order and this is just for 6 months since the Liquor License will renew again in January. Ms. Peterson said the Control Plan and Certificates are in order. The background on one of the servers, Mr. Eric Bejarno showed he was convicted of DWAI on 3/19/14. Mr. Hepworth said Mr. Bejarno has just received his driver's license back and has completed what was required of him.

City Attorney Shaver asked Mr. Hepworth to describe how they would conduct the tastings. Mr. Hepworth said they would conduct the tastings from 3:30 p.m. to 6:30 p.m. on the first, third, and last Thursdays of each month and they have 23 scheduled. They will do either beer or wine, alternating weeks. Tasting product will not leave the premise and will be disposed of at the conclusion of the tasting by dumping all unused product down the drain and discarding all bottles. ID's will be checked prior to tasting.

Hearing Officer Grattan marked the Control Plan as Exhibit A (see attached) and entered it into the record. Hearing Officer Grattan asked City Attorney Shaver what his thoughts on Mr. Bejarno being on the tasting permit with his DWAI.

City Attorney Shaver said that due to this being a tasting permit, and not another type of license, he is okay with having Mr. Bejarno stay on the tasting permit.

Hearing Officer Grattan asked if there was anyone in attendance who objected to this request. Seeing none, Hearing Officer Grattan approved the Tasting Permit for approximately 6 months and then it will renew with the Retail Liquor license in January, 2016.

Hearing Officer said he wants to work with Ms. Maestas and will continue this to June 3, 2015 and asked Ms. Peterson to contact Ms. Maestas so she will be prepared to attend and give an update on the process of moving her location.

Mr. Rob Schoeber and Ms. Robin Brown, were both present.

Ms. Peterson reported the paperwork was in order and all reports are in compliance except Sales Tax. Ms. Peterson said that this was two separate events last year and there were issues at both, the applicants were different but Ms. Brown was the Event Manager for both.

City Attorney Shaver handed Ms. Brown three pages. The first two pages were marked with an "A" in the upper right hand corner and the next document with a "B" (see attached). City Attorney Shaver asked Ms. Brown if she if familiar with these documents. She answered yes, that she completed these documents. City Attorney Shaver asked Ms. Brown whose signature that was on the second page of Exhibit A. She said it was hers. City Attorney Shaver asked Ms. Brown to describe the event. Ms. Brown said this would be the first time for these

events to be held together but both have been held separately. City Attorney Shaver asked Ms. Brown if there have been any incidents with the past two events. Ms. Brown said at the Art & Music Festival they had a bartender who took a bottle of wine off the licensed premise into Boomers as they were using the establishment as a headquarters. She was contacted by Officer Keech that this occurred. She said she learned several things from this event. Then at Epic Rides, they were serving after the time frame and Ms. Brown said she did not realize people could not consume after that time, she though it was only for selling the alcohol. Ms. Brown said that is why she has adjusted the hours for this year's event. Staff of Two Rivers Convention Center will be in charge of selling and Lonestar Security will be the professionals checking ID's along with another company who Don Bedford is in charge of and those volunteers will have t-shirts with "Security" marked on them. Ms. Brown said there were no citations issued from the two incidents.

Hearing Officer Grattan asked about the blank where the sales tax number should be. Ms. Brown said they are currently working on this. Since the City is applying, there are several sales tax numbers and she is working with that department.

City Attorney Shaver said he would recommend approval and entered the Exhibits into the record.

Hearing Officer Grattan asked if there was anyone present who is in favor or against this request. Hearing Officer Grattan found that pursuant to Colorado State Statutes 12-48-106, there were no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event, and its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He trusts that the issues from the previous events would not happen again. He found that the application for a special event permit submitted by the City of Grand Junction was in order and approved it conditioned on the sales tax number being provided.

Mr. Doug Sorter, Event Manager, was present. Mr. Sorter said they now have a President who is Dr. Sharon Jacksi. Hearing Officer Grattan said this will be noted.

Ms. Peterson reported that all the paperwork is in order and reports are in compliance.

City Attorney Shaver handed Mr. Sorter three pages. The first two pages were marked with an "A" in the upper right hand corner and the next document with a

"B" (see attached). City Attorney Shaver asked Mr. Sorter if he if familiar with these documents. He answered yes, that he completed these documents. City Attorney Shaver asked Mr. Sorter whose signature that was on the second page of Exhibit A. He said it was his. City Attorney Shaver asked Mr. Sorter to describe the event. Mr. Sorter said this would be the first time for this event and it will take place in the front lawn area of the Western Colorado Botanical Gardens. This is a private event and they will only sell 100 tickets in advance. This is a fundraiser for children's services. They have a permanent fence that covers the entire area. This is a secure location. Mr. Sorter will train the volunteers before the concert and training materials will be provided. City Attorney Shaver asked Mr. Sorter if there have been any incidents with the past at any of the events he has been responsible for. Mr. Sorter said no. Security will be provided by CSI (Citadel Security and Investigation) and they will be in uniforms, and the staff will be identified with yellow vests. Mr. Sorter said they have held past events here and in the amphitheater but are going to hold all of them at this location from now on. It will be easier for them to control.

Hearing Officer Grattan asked if there was anyone present who is in favor or against this request. Hearing Officer Grattan found that pursuant to Colorado State Statutes 12-48-106, there were no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event, and its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that the application for a special event permit submitted by the Western Colorado Botanical Society was in order and approved it.

Mr. Doug Sorter, Event Manager, was present.

Ms. Peterson reported that all the paperwork is in order and reports are in compliance.

City Attorney Shaver handed Mr. Sorter three pages. The first two pages were marked with an "A" in the upper right hand corner and the next document with a "B" (see attached). City Attorney Shaver asked Mr. Sorter if he if familiar with these documents. He answered yes, that he completed these documents. City Attorney Shaver asked Mr. Sorter whose signature that was on the second page of Exhibit A. He said it was his. City Attorney Shaver asked Mr. Sorter to describe the event. Mr. Sorter confirmed that this is 4th year this concert series has taken place, but always before at the amphitheater. He said this event is open to the public not like the previous event application. He will be present at

all events to make sure everything is in compliance. The concert on August 22 could have the most participants due to the band but he does believe the staff will be able to keep it in control. Again he said that this would be a better location for the event and it will take place in the front lawn area of the Western Colorado Botanical Gardens. They have a permanent fence that covers the entire area. This is a secure location. Mr. Sorter will train the volunteers before the concert and training materials will be provided. City Attorney Shaver asked Mr. Sorter if there have been any incidents with the past at any of the events he has been responsible for. Mr. Sorter said no. Security will be provided by CSI (Citadel Security and Investigation) and they will be in uniforms, and the staff will be identified with yellow vests.

Hearing Officer Grattan noted there was no one else in the room. Hearing Officer Grattan found that pursuant to Colorado State Statutes 12-48-106, there were no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event, and its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that the application for a special event permit submitted by the Western Colorado Botanical Society was in order and approved it.

VI. <u>OTHER BUSINESS</u>

Hearing Officer Grattan made note that the only ones left in the hearing room are Deputy City Clerk Peterson, City Attorney Shaver, and himself.

Hearing Officer Grattan asked if there has been a report from the Cinco de Mayo Special Event. Ms. Peterson said she has not received one as of today.

Hearing Officer Grattan asked for an update on the CMU Arts license that came before him several weeks ago. Ms. Peterson said the State has required President Foster to be on the license and their office just received President Foster's fingerprints so she has forwarded the Individual History for him to the State and submitted the fingerprints to C.B.I. It was agreed by City Attorney Shaver and Hearing Officer Grattan to wait to see what the State decides.

Hearing Officer Grattan asked about the special hearing for CMU Beer Fest being held on May 15th. Ms. Peterson said it appeared that the paperwork just fell through the cracks. Ms. Peterson said last year they had one contact person and it doesn't seem like she is doing that for every event. Hearing Officer Grattan said he would like to have a conversation with CMU to make sure this doesn't happen again, if there could be one contact person. City Attorney Shaver said this could cause some political ripples. City Attorney Shaver said he will not be at the May 15th Liquor and Beer Meeting but Staff Attorney Shelly Dackonish will be.

We will ensure that ID's are checked prior to tasting and will follow the 7 legal forms of Identification within the State of Colorado guidelines.

We will not sample any visibly impaired or intoxicated persons.

We will only allowing each person to sample up to four product samples consisting of no more than 1 ounce pours. Each tasting will be either beer or wine. The two will not be combined for one tasting. Tasting product will not leave the premise and will be disposed of at the conclusion of each tasting by dumping all tasting product down the drain and disarding all bottles. Samples will be provided free of charge.

Samples to be tasted will be served in required disposable cups or containers in size that contains a one ounce serving.




