Corridor Plan Update: Right-of-way (ROW) acquisition negotiations with property owners will begin now that the appraisals have been completed. We are still on track to begin construction ~September 8, 2015.

<u>Updating the Economic Impact Report:</u> Jay and Vara shared the proposal from Matthew Rosenberg and Nathan Perry of the CMU Business School to update the 2011 Economic Impact Study. After discussion,

<u>Ciavonne Scope of Work:</u> The board reviewed a proposal letter from Ted Ciavonne detailing his scope of work for introducing the horse sculptures into the roundabouts, appropriate coordination to the RAMP grading, landscape, irrigation, and lighting work, as well as coordination of artist Joseph Fichter and his structural engineer. Chuck Keller made a motion to accept the proposal as written, Darshann Ruckman seconded the motion, and it passed unanimously.

<u>Safety Cards:</u> The board reviewed a proposed postcard-sized safety card to be distributed to motels. One side asks visitors to be mindful crossing Horizon Drive. The other side lists restaurants according to which side of Horizon they are located on. The cards will be printed and distributed before JUCO.
