## Minutes July 10, 2001

## Call to Order

## **Old Business**

<u>Urban Trails Master Plan Revision</u>: Discussed comments received from open house. Talked about priority of comments and believe priorities are high, however, there are barriers beyond UTC's control. South Camp is in the works per City and must follow their timeline and budget. Talked about "priority" rating system and how it's confusing for non-UTC members. Jody's office has requested that priorities by prioritized.

Ken said everyone would need to help tidy up the spreadsheets. Ken proposed everyone adopt his or her section and find a pattern and flow that makes sense and is consistent. Example: Route: East/West (west boundary to east boundary) or North/South (top to bottom). How to list them – start at top with northern most east/west route and work way down.

Priority 1 will now be for everything that is critical, A = easy can do now, B = problems, money/barriers. Priority 2 will be for everything that is a lower priority, A and B will be same as priority 1. Jamie has concerns about priority listing as part of presentation. Priority listing should be used for internal use only.

Shawn asked about designation wording – path, lane, route, etc. Kens is concerned about what to call "off street pathways", would like not to give more designations since they are multiuse. Shawn stated everything the City uses in publications is "trails". UTC will change pathways to trails.

Jamie said Monument staff commented that UTC should show UTC trails connecting to their trails and then to the BLM trails. Group agreed it was a good idea.

Ken thinks mapping should be done within the week. Next step will be to meet with staff and then strategy of how to present to Council/Commission. Should go through Brad Taylor and Parks Board (Shawn). Jamie asked Shawn what all UTC should share with Parks Board.

## **New Business**

Ken asked about trails in Redlands Mesa. Jamie is concerned about 10<sup>th</sup> hole.
