Called to Order

Old Business – Signage: Jennifer and Julie talked about what was discussed at last meeting. Julie talked about conversation with John Gormley and what he said and what group needs to do and who to contact.

Bike Racks – Julie and Jennifer walked Main Street to count bike racks. Shawn said the Main Street revamp includes bike racks. Shawn will bring master plan and picture of racks to January meeting.
