### Item 6: Planning for Arbor Day and Yard of the Month

Tom Ziola gave Kamie Long seeds from the State Champion Dawn Redwood tree located here in Grand Junction, to begin growing seedling trees at the Fort Collins Nursery for the City of Grand Junction's Arbor Day Program.

Board members began discussing 2015 Southwest Arbor Fest and decided to move forward with having a Kids Tree Climbing area, Guess the Height and Width of a Tree, Tree Seedling Giveaway, as well as a kids activity. Shirley Nilsen will contact Lowe's on kids building bird houses at the event.

The 2015 Arbor Day Student Poster Contest will be open to K-5<sup>th</sup> grade students of local School District 51 schools. Flyers will need to be sent out to schools informing them of the program. Tom Ziola will contact CPC Solutions, as well as Peczuh for bids on Arbor Day poster pads of paper. Jessica Dennison suggested only providing a single pad of paper to each class, versus each student to save on costs. Shirley Nilsen stated someone will need to contact the School District about protective laws on displaying student's names on the winning posters at City Hall.

The Forestry Advisory Board will be going on their eighth year for Yard of the Month. Each board member will be assigned one month to organize, judge yards, interview winners, as well as write an article for the Daily Sentinel.
