

POLICEMEN'S PENSION BOARD MEETING

September 25, 1941  
8:30 A.M.

A meeting of the Policemen's Pension Board was held at 8:30 A.M., September 25, 1941, at the office of the City Manager.

Present: Bruce Brownson, President; Robert A. Hart, Secretary; Francis I. Stringer, Treasurer; Helen C. Tomlinson.

Dr. H. C. Graves appeared before the Board and offered further testimony concerning the disability of Patrolman Culver S. Harris in addition to the following statement submitted by him on August 28:

"I was called to see Mr. C. S. Harris, 412 Teller Avenue, on July 31, 1941. He was suffering from a cerebral hemorrhage commonly known as a "stroke" which had partially paralyzed his left arm. His blood pressure was over 200 and his condition precarious. At present his blood pressure is down to nearly normal. The left leg is capable of motion and some use but the left arm has improved only slightly.


"His outlook in regard to employment is of course doubtful. The function in the left arm may or may not return or it may return in part. In my judgment it would be that he will make a recovery which will permit him in the neighborhood of 50% of his previous functional capacity as a working unit. If he is sufficiently conscientious in the care of himself, his life expectancy may not be greatly reduced."

After hearing the testimony of Dr. Graves and discussing the provisions of Section 524, Chapter 163, CSA, relating to Pensions--Temporary and Permanent Disability--Death--Beneficiaries, the following motion was unanimously passed: that

WHEREAS, the testimony of Dr. Graves indicated that Patrolman Harris' degree of recovery could probably be definitely determined within 60 or 90 days,

temporary disability be granted to Patrolman Harris beginning September 1, 1941, until December 31, 1941, on or before which date a re-hearing will be held.

There being no further business to come before the Board the meeting was adjourned.

The meeting of the Board was held in the office of the City Manager. The purpose of this meeting was to organize and elect officers of the board. Members are as follows:


