Present; City Manager Toyne President of the Pension Board. Fred E. Hagie Treasure; Henry M. Patterson Secretary; and Mrs-Helen C. Tomlinson.

The case of Lt. Albert Frazier retired member of the Grand Junction Police Dept: Residence 862 Ute Ave Grand Junction Colo. was taken up.

Albert S. Frazier died August 26 1949 and left a widdow Mrs-Clarabelle Frazier and no minor children;

It was unimous agreed and voted by the Pension Board that Mrs - Clarabelle Frazier widdow of Albert S. Frazier be given Mr Frazier's last Pension Check up to August 26 1949.

Beginning September 1 1949 it was unimous agreed and voted that the Widdow of Albert S. Frazier Clarabelle Frazier shall recive \$30.00 Thirty Dollars per month in accordance of Chapter 524; 163 C.S.P. 1935 Colorado Statutes Annotated.

A meeting of the Policeman's Pension Board was held at 8:30 A.M. April 2, 1948 in the office of the City Manager, to take up the case of Clyde Sanders, Patrolman, Grand Junction Police Department, Grand Junction Colorado.

Present Tom I. Moore, President, Fred Hagie Treasurer, Henry M. Patterson Secretary, and Helen C. Tomlinson.

This case was discussed and it was unamimously voted by the board that Patrolman Clyde Sanders be granted temperary disability beginning April 1, 1948 and not to exceed Sixty (60) days.
