RESOLUTION NO. 8-89

DECISION ON APPLICATION FOR A HOTEL-RESTAURANT LIQUOR LICENSE BY OMER R. CATT, UNDER THE TRADE NAME OF JOAN'S LOCATED AT 2456 INDUSTRIAL BOULEVARD, GRAND JUNCTION, COLORADO

A public hearing was scheduled for December 6, 1989, on the application by Omer R. Catt, for a hotel-restaurant liquor license under the trade name of Joan's, located at 2456 Industrial Boulevard, Grand Junction, and the Local Licensing Authority having considered the evidence adduced at said hearing, FINDS:

- 1. The hearing held on December 6, 1989, on the application was held after proper notice thereof under C.R.S. 12-47-101, et seq.
- 2. The survey of the neighborhood conducted by the City revealed that 41 persons believed the needs of the neighborhood were being met by existing outlets, while 72 felt the needs were not being met. Of those who were inhabitants of the neighborhood, 4 desired that the license issue and 0 were opposed to the issuance of the license. The applicant submitted a petition signed by 13 people who were in favor of the issuance of the license.
- 3. No one appeared at the hearing in opposition to the granting of the license and no petitions of disapproval were received by the Local Licensing Authority.
- 4. The moral character and reputation of the applicant is good as determined by a check done by the Police Department.
- 5. There is one existing outlet of a similar type within the area surveyed by the City, and one existing outlet of a similar type within one mile.
- 6. The evidence supports the conclusion that the needs of the neighborhood are not being met by other outlets and it is the desire of the adult inhabitants of the neighborhood that the license issue.
- 7. The building where the license is sought is located more than 500 feet from any public or parochial school or the principal campus of any college, university or seminary.

NOW, THEREFORE, BE IT RESOLVED BY THE LOCAL LICENSING AUTHORITY OF THE CITY OF GRAND JUNCTION:

That the application by Omer R. Catt for a hotel-restaurant liquor license under the trade name of Joan's, located at 2456 Industrial Boulevard, Grand Junction, Colorado, be granted.
