#### RESOLUTION NO. 4-90

DECISION ON APPLICATION FOR A
HOTEL-RESTAURANT LIQUOR LICENSE BY
PATRICK H. VASQUEZ UNDER TRADE
NAME OF THE YELLOW ROSE-ROSA AMARIA
LOCATED AT 718 HORIZON DRIVE,
GRAND JUNCTION, COLORADO

A public hearing was scheduled for June 6, 1990, on the application by Patrick H. Vasquez for a hotel-restaurant liquor license under the trade name of The Yellow Rose-Rosa Amaria located at 718 Horizon Drive, Grand Junction, Colorado, and the Local Licensing Authority having considered the evidence adduced at said hearing, FINDS:

- l. The hearing held on June 6, 1990, on the application was held after proper notice thereof under C.R.S. 12-47-101, et seq.
- 2. The survey of the neighborhood conducted by the City revealed 52 persons believed the needs of the neighborhood were being met by existing outlets, while 83 felt the needs were not being met. Of those who were inhabitants of the neighborhood, 75 desired that the license issue and ll were opposed to the issuance of the license. The applicant submitted a petition signed by 77 people who desired that the license issue.
- 3. No one appeared at the hearing in opposition to the granting of the license, and no petitions of disapproval were received by the Local Licensing Authority.
- 4. The moral character and reputation of the applicant is good as determined by a check done by the Grand Junction Police Department.
- 5. There are eight (8) existing outlets of a similar type within the City and one (1) within the County located within the area surveyed by the City and within one mile of the proposed outlet.
- 6. The evidence supports the conclusion that the needs of the neighborhood are not being met by other outlets, and it is the desire of the adult inhabitants of the neighborhood that the license issue.
- 7. The building where the license is sought is located more than 500 feet from any public or parochial school or the principal campus of any College, University, or Seminary.

NOW, THEREFORE, BE IT RESOLVED BY THE LOCAL LICENSING AUTHORITY OF THE CITY OF GRAND JUNCTION:

That the application by Patrick H. Vasquez for a hotel-restaurant liquor license under the trade name of the Yellow Rose-Rosa Amaria located at 718 Horizon Drive, Grand Junction, Colorado, be granted.
