- I. CALL TO ORDER - The meeting convened at 8:00 a.m. Those present were Hearing Officer Phil Coebergh and City Clerk Stephanie Nye.

II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

- A. Fishers Liquor Barn, 2448 F Road, (Retail Liquor Store)
The application was in order, and approved.
- B. Chelsea London Pub, 2424 Highway 6 & 50, Unit #300, Mesa Mall (Hotel-Restaurant) - This application was postponed pending the filing of the registration for the new manager.
- C. C & F Food Store #1, 859 Pitkin Avenue (3.2% Beer)
The application was in order, and approved.
- D. C & F Food Store #3, 596 25 Road (3.2% Beer)
The application was in order, and approved.
- E. C & F Food Store #4, 2714 Highway 50 (3.2% Beer)
The application was in order, and approved.

Assistant City Attorney John Shaver joined the meeting at 8:02 a.m.

III. APPLICATIONS FOR CHANGE OF OWNERSHIP

- A. Application for a Retail Liquor Store License by Eric David McCarty dba McCarty, Inc., North Avenue Liquor, 801 North Avenue (License presently held by Woldruff, Inc.)

David McCarty was present, stating that he is presently filing for incorporation with the help of his attorney. He was made aware that upon completion of the incorporation he would have to file another change of ownership application under the name of the corporation. Mr. McCarty understands from his attorney that he can apply as a closely held corporation and still use the name McCarty, Inc., and a "dba." He stated that "McCarty, Inc." is his registered trade name with the State of Colorado.

The application was in order, and approved. City Clerk Stephanie Nye clarified that if Mr. McCarty wishes to put the liquor license in the corporation name, it means going through the same process again with all the same fees, same forms, getting a lease assignment to the corporation, etc. The Hearing Officer advised Mr. McCarty to get with his attorney to resolve this.

IV. APPLICATION FOR NEW LICENSE

- A. Application for a 3.2% Beer License by Feather Petroleum Co., dba Stop 'N Save #4, 2700 South Highway 50

Sec/Treas: Stanley R. Medsker

Hearing Officer Phil Coebergh explained that there was a license at this location previously, and it was allowed to expire through an oversight. They are now operating under a temporary license. Larry Feather, corporation president, was present.

City Clerk Stephanie Nye read the report into the record (copy attached). There were no opponents, letters or counterpetitions. The application was in order, and approved.
