MINUTES

I. <u>CALL TO ORDER</u> - The meeting convened at 8:02 a.m. Those present were Hearing Officer Philip Coebergh, Assistant City Attorney John Shaver, and City Clerk Stephanie Nye.

II. DECISION ON MANAGER'S REGISTRATION

A. Application by Grand Junction London Pub, Inc., dba Chelsea London Pub, 2424 Highway 6 & 50, Unit #300, Mesa Mall, to Register Haskell Wayne Howell as Manager of its Hotel-Restaurant Liquor License

Hearing Officer Coebergh stated that he spoke with the City Attorney regarding this application concluding that there is insufficient basis to deny the application on the local level based on the history that was presented on Mr. Howell. The application was approved.

- A. Stop 'N Save No. 2, 2050 North Avenue (3.2% Beer). The application was in order, and approved.
- B. Club Zephyr, 715 Horizon Drive (Tavern)
 The application was in order. The application was approved subject to the receipt of a clear Police Department report.
- C. Freeway Bowl, 1900 Main Street (Tavern)
 The application was in order, and approved.
- D. Pantuso's Italian Ristorante, 2782 Crossroads Boulevard (Hotel-Restaurant)

The application was in order, and approved.

- E. Canyon Convenience Store No. 3, 1134 N. 12th Street (3.2% Beer) The application was in order, and approved.
- F. Talley's Bar-B-Q & Biscuit Factory, 623 Main Street (Beer-Wine) The application was in order. The application was approved subject to compliance with the Mesa County Health Department report which stated two critical violations.

The applicant had difficulty getting a corporate name approved by the State which has caused delays. The applicant is now caled G.J. North Avenue Liquors, Inc.

Assistant City Attorney John Shaver stated that he advised the City Clerk to bring this item back to the Hearing Officer merely to affirm the prior action, and to revisit the issue prior to filing with the State.

The Hearing Officer ratified the incorporation of GJ North Avenue Liquors, Inc.
