I. **CALL TO ORDER** - The meeting was convened at 8:08 a.m. Those present were Hearing Officer Philip Coebergh, Assistant City Attorney John Shaver and Acting City Clerk Christine English.

II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

A. Silver House, 2886 North Avenue (Beer-Wine)
Acting City Clerk Chris English stated the Health Department found two violations which have been corrected. The application was in order, and approved.

B. Diamond Shamrock, 2903 North Avenue (3.2% Beer)
The application was in order and approved.

C. Diamond Shamrock, 201 North Avenue (3.2% Beer)
The application was in order and approved.

D. Diamond Shamrock, 2498 F Road (3.2% Beer)
The application was in order and approved.

E. Diamond Shamrock, 2525 Broadway (3.2% Beer)
The application was in order and approved.

F. River City Cafe, 748 North Avenue (Hotel-Restaurant)
The application was in order and approved.

III. **APPLICATION FOR SPECIAL EVENTS PERMIT**

A. Application by the Downtown Association for a Malt and Vinous Liquor Special Events Permit on April 22, 1995, from 10:00 a.m. to 12:00 Midnight, on Main Street, between 5th Street and 7th Street, for the Annual Chili Cook-Off and Farm & Ranch Day

Wendy Schade, Administrative Secretary for the Downtown Development Association, was present. The application was in order with the exception of the letter from the Downtown Development Association showing the need for the issuance of a one day liquor license. Hearing Officer Philip Coebergh stated the DDA would have to comply with the State Statutes requiring this letter. Assistant City Attorney John Shaver agreed with this and the application was approved contingent upon receipt of the letter showing need. The DDA was given seven (7)

days to comply with this requirement.
