# III. HEARINGS FOR SPECIAL EVENTS PERMIT

A. Application by the Downtown Association for a Malt, Vinous and Spirituous Liquor Special Events Permit for the Arts and Crafts Festival on June 9 and June 10, 1995 from 9:00 a.m. to Midnight located on Main Street between 3rd and 7th Avenues

Wendy Schade, Administrative Secretary, Downtown Development Authority, was present. The application was in order. The letter meeting State Statute requirements concerning special needs for the event was read into the record. The letter was accepted by the Hearing Officer and Assistant City Attorney. The application for the permit was approved.

B. Application by the Downtown Association for a Malt, Vinous and Spirituous Liquor Special Events Permit for Dinosaur Days on July 22, 1995 from 9:00 a.m. to Midnight located on Main Street between 3rd and 7th Avenues

Wendy Schade was present representing the Downtown Development Authority on this application also. The application was in order. The letter meeting State Statute requirements concerning special needs for the event was read into the record. The letter was accepted by the Hearing Officer and Assistant City Attorney. The application for the permit was approved.

C. Continuation on Application by the B.P.O. Elks #575 for Malt, Vinous and Spirituous Liquor Special Events Permit for their 95th Birthday Celebration on May 27, 1995 from 9:00 a.m. to 9:00 p.m. at 249 South 4th Street. Continued from May 3, 1995 Liquor and Beer Meeting

Bruce Kassebaum, Manager for the Elks Lodge was present. application was in order. The letter meeting State Statute requirements concerning special needs for the event was read into the record. Assistant City Attorney John Shaver stated that the letter closely addresses the State Statutory criteria and recommended approval. Hearing Officer Philip Coebergh questioned Mr. Kassebaum why he had not appeared at the last scheduled meeting as required.
