Subject: Application by Melissa Sherman, LLC for a Hotel-Restaurant Liquor License at 319 Main Street under the name of Melissa's Table

Melissa Sherman, LLC, a limited liability company, filed an application with the Local Licensing Authority on July 19, 1996, for a hotel-restaurant liquor license, for the sales of malt, vinous and spirituous liquors by the drink for consumption on the premises at 319 Main Street under the trade name of Melissa's Table. The application and supplementary documents were reviewed, found to be in order and accepted. The hearing date was set for August 21, 1996. The Notice of Hearing was given by posting a sign on the property on August 9, 1996 and by publishing a display ad in <u>The Daily</u> <u>Sentinel</u> on August 9, 1996.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey and defined the neighborhood as the area bounded by the Chipeta Avenue on the north, DR&RGW Railroad Tracks on the south, 8th Street on the east and Mulberry Street on the west and included both sides of the streets as the outer boundaries. The results of that survey are as follows:

1. As an owner of property in the neighborhood, an employee of or business lessee of property in the neighborhood, and/or an inhabitant residing in the neighborhood for more than six months each year, I believe the reasonable requirements of the neighborhood are already being met by existing outlets.

2. As an inhabitant residing in the neighborhood more than six months each year, it is my desire that the license be issued.

YES: 24 NO: 0 NOT APPLICABLE: 0

No letters of opposition or counterpetitions have been filed to date.

The applicant, Melissa Sherman, L.L.C., is a limited liability company with one member. Local criminal history has been completed and the fingerprints have been forwarded to the Colorado Bureau of Investigation for further processing. The Grand Junction Police Department found no local criminal history on Melissa Sherman.

The City's Code Enforcement Division visited the premises and verified that the establishment is as shown on the diagram submitted. The Health Department has reviewed the plans and will conduct a final inspection prior to opening. The Fire Department has also reviewed the plans and will complete a final inspection once the building is certified for occupancy by the building department.

The City's Community Development Dept. has advised that no Conditional Use Permit is required for this operation as proposed.

This letter is in regards to your request to show that other existing facilities are not available or are inadequate for the needs of the event. We approached the Hilton to use their facilities, which were adequate, but they had no availability on the dates we requested. The Ramada did not have adequate outside facilities for our Highland games. We also tried to get Lincoln Park, but the city did not want their facilities used for our purpose. The games require an outside area large enough to accommodate events such as the caber toss, the hammer toss, and other such events; an

inside area would not be appropriate and an outside area must be able to accommodate such events.
