#### MINUTES

WEDNESDAY, MARCH 19, 1997, 8:00 A.M.

I. <u>CALL TO ORDER</u> - The meeting convened at 8:02 a.m. Those present were Hearing Officer Phil Coebergh, Assistant City Attorney John Shaver and City Clerk Stephanie Nye.

#### II. APPLICATION TO RENEW LIQUOR AND BEER LICENSES

- 1. Loco Inc., dba Loco Food Store #11, 1904 North 12th Street, 3.2% Beer
  The application was in order and approved.
- 2. Loda Inc., dba Mama Longos, 2830 North Avenue, Beer and Wine with Extended Hours
  - The application was in order and approved.
- 3. Canyon Convenience Inc., dba Canyon Convenience Store #3, 459 North Avenue, 3.2% Beer
  - The application was in order and approved.

Application by Grand Junction Downtown Association for a Malt, Vinous and Spirituous Liquor Special Events Permit for "Southwest Fest" on April 19, 1997 from 7:00 a.m. to Midnight, "Art & Jazz Festival" on June 6 & 7, 1997 from 7:00 a.m. to Midnight, and "Dinosaur Days" on July 19, 1997 from 7:00 a.m. to Midnight, all to be located on Main Street

This application reflects 3 requests for Special Events Permits. Steve Jennings representing the Downtown Association was present. City Clerk Nye read into the record the letter requesting the permit (see attached). Assistant City Attorney Shaver stated the requirements of the State Statutes had been met. The application was in order and approved.

#### V. SHOW CASE HEARING

1. Jeffrey Inks dba The Chameleon Club, 234 Main Street, Tavern with Extended Hours

On or about January 9, 1997, Jeffrey Inks, owner and licensee of The Chameleon Club, sold, served, or distributed malt, vinous or spirituous liquor after permitted hours in violation of 12-47-128 C.R.S. UNLAWFUL ACTS and Colorado Liquor Regulation 47-128.2.

Brad Junge, attorney, and Jeffrey Inks were present. Assistant City Attorney Shaver stated the hearing on the verified complaint had originally been set for a hearing on February 19, 1997. The licensee was contacted after hours by Grand Junction Police on the suspicion of the contents of the complaint. A stipulation and agreement pertaining to the licensee will be entered today. This provides for a 2 day suspension of the license to be held in abeyance for 6 months with a fine in lieu of an active suspension set at \$237.59. Assistant City Attorney Shaver recommends approval of the stipulation with the defined conditions. Mr. Junge stated Mr. Inks has paid a fine and completed the community service involved with the petty offense matter. Mr. Junge apologized for not being present at the last hearing. He stated he and Mr. Inks are prepared to sign

the stipulation this day. Mr. Inks stated he has obtained a code book and he and his staff have taken steps to be in compliance with the law. Mr. Junge stated Mr. Inks has applied for a business/residence use of the premises. Assistant City Attorney Shaver stated this may not be possible but he has provided the licensee with his comments on this matter. The stipulation was approved and ordered signed.

VI. ADJOURNMENT - The meeting was adjourned at 8:21 a.m.
