Hearing Officer Coebergh requested Ms. English to briefly state the situation with the licensee. Ms. English stated the renewals were received the first week of March, 1998. put the licensee on the border line of the 30 day prior to expiration date renewal At that time seven (7) checks accompanied the applications in the amount of \$57.50 Ms. Humphrey was contacted that day and told the correct amount for a City license is \$53.75. Ms. Humphrey stated she had called the City Clerk's office and she the fee was \$57.50 each. Ms. Humprey requested the renewals be returned be issued for thecorrect amount. The renewals were received on March 19, the correct amount. This put the licensee well past the 30 day renewal again contacted Ms. Humphrey and explained about the late renewal letter of explanation from her stating why the renewals were late. That March 23, 1998. A copy of the agenda was sent to Ms. Humphrey 10 days hearing with a note attached stating a representative needed to be present.

Hearing Officer Coebergh asked Mr. Shaver as to the procedure for renewal applications? Mr. Coebergh concurred with Mr. Shaver. Mr. Shaver stated there maybe some confusion in the statute he cited which is Article 47 of Title 12 of the Liquor Code. Specifically, since we are dealing with 3.2% beer licenses the applicability of Article 47 of Title 12 is established via 12-46-102.2 C.R.S. which states "to aid administrative efficiency, the provisions in Article 47 of Title 12 shall apply to the regulation of fermented malt beverages except when otherwise expressly provided for in this Article". That is why the reference is made to 12-47 instead of 12-46.
