II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

1. LS & L Restaurant Corporation dba Big Cheese Pizza, 810 North Avenue, Hotel-Restaurant

The application was in order and approved.

2. Granber Incorporated dba G.B. Gladstones, 2531 North 12th Street, Hotel-Restaurant

Mr. Frank Bering was present representing G.B. Gladstones. Mr. Bering stated he was present to address any problems, which may have come up during the renewal process. The application was in order and approved.

Mer Stevenson was present representing The Pour House. The Fire Department reported 2 critical violations. A re-inspection has been scheduled for Novembe 1, 1998. The Health Department reported 2 critical violations. One was corrected at the time of the inspection. The other violations involve the need for a hand-washing sink to be installed. Mr. Stevenson stated the Fire Department violations involved the replacement of ceiling tiles and the use of extension chords. The ceiling tiles are in the process of being replaced and the extension chords are no longer being used. The Health Department violation on the hand-washing sink is also in the process of being corrected. The application was in order and was approved contingent upon favorable re-inspection reports from the Fire and Health Departments.
