MINUTES

WEDNESDAY, AUGUST 16, 2000, 8:00 A.M.

I. <u>CALL TO ORDER</u> – The meeting was convened at 8:02 a.m. Those present were Hearing Officer Phil Coebergh, Assistant City Attorney John Shaver and Senior Administrative Assistant Christine English.

II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

1. G. Roger Warren dba This Is It Grocery, 215 South 11th Street, 3/2% Beer Off Premise

The application was in order and approved.

 Loco Incorporated dba Loco Food Store No. 12, 107 Grand Avenue, 3.2% Beer Off Premise

The application was in order and approved.

3. MX Incorporated dba Dolce Vita, 336 Main Street 101-104, Hotel and Restaurant

Sharme Perucchini was present. The Health Department reported several critical violations. A follow up inspection was scheduled for August 1, 2000. No report has been received to date on the follow up inspection. The application was in order and approved contingent upon a favorable Health reinspection report.

4. Mill Inn Incorporated dba WW Peppers Ltd., 753 Horizon Drive, Hotel and Restaurant

The application was in order and approved.

III. APPLICATION FOR RENEWAL AND DECISION ON CAUSE FOR LATE FILING

1. Thrifty Payless Incorporated dba Rite Aid #6367, 400 North 1st Street, 3.2% Beer Off Premise-License Filed August 1, 2000, License Expires August 26, 2000

Matt Chamberlain, manager, was present. Ms. English submitted the letter on cause for late filing to Mr. Coebergh and Mr. Shaver (see attached). Mr. Shaver stated the letter is unclear as to the specific cause for late filing on this license. The surrendering of other licenses does not effect this license. Mr. Shaver stated since the license had not expired, it was his recommendation to approve the application for renewal. The application was in order and approved. Mr. Coebergh admonished Mr. Chamberlain to file the renewal in a timely manner in the future.

IV. REPORT OF CHANGE IN CORPORATE STRUCTURE

1. City of Grand Junction dba Two Rivers Convention Center, 159 Main Street, Hotel and Restaurant

The application was filed in a timely manner, was in order and approved.

Sydney Smith, secretary, was present. The report from C.B.I indicated that two of the officers have some arrests in their backgrounds. On the individual history forms, Mr. Topliss answered the question regarding any convictions in his background "No". Mr. Knauss did list charges in 1998, 1982, and 1979, but two of the arrests were not reported. Mr. Smith stated there is also a drug related charge. Mr. Coebergh asked if any convictions were indicated on the reports. Ms. English stated that information was not available from the report.

Mr. Shaver recommended since this was filed in a timely manner, that it be continued to the next meeting giving time for further investigation. Mr. Coebergh concurred. The report of change in corporate structure was continued to the September 6, 2000 meeting.

V. APPLICATION FOR MODIFICATION OF PREMISES

1. Beye Lotz VFW Post 1247, 1404 Ute Avenue, Tavern

Add 60' x 70' addition with larger kitchen and service bar

John McCulley, quartermaster, and Bob Noland, ex-quartermaster, were present. The application was in order. The modification of the premises was reported by Brian Turner, State Liquor Enforcement Officer. Mr. McCulley was notified that he needed to file an application and came to the City Clerk's office that day to pick up the necessary paperwork. The modification began in May 1999 and was completed in July 2000.

Mr. Shaver recommended approval of the application. The City Attorney's office would conduct an investigation as to whether or not a violation of the liquor code occurred with the filing of the application taking place after completion of the project.

The application for modification of premises was approved.

VI. <u>APPLICATION FOR TRANSFER OF OWNERSHIP</u>

1. Leon's Taqueria Restaurant, Incorporated dba Leon's Mexican Restaurant in the Mall, 2424 Highway 6 & 50 #232, Hotel and Restaurant

Felipe Leon, president, and Judy Briggs, office manager, were present. Ms. English reported that Leon's Taqueria Restaurant Inc., bought out Tres Hermanos Inc., taking over Leon's Todo Bien in Mesa Mall. This occurred in June 2000. The application for transfer of ownership was filed after this occurred. At that time, they were notified that they could not be serving alcohol until the application was filed, reviewed, accepted and a temporary permit issued. A temporary permit was issued to them on July 28, 2000. As of August 15, the applicant still needed to file a copy of a fully executed lease covering the entire licensing period, an attachment to the application on question #10, and a copy of the original loan papers. There is also a question of whether or not a city sales tax license has been applied for.

Ms. Briggs stated she had turned in the attachment yesterday. Ms. Briggs submitted to some documents to the Licensing Authority. Ms. English stated it was turned in after she had left for the day and had not had a chance to review it this morning. Mr. Coebergh admonished the applicant that requested documents must be submitted in a timely manner so there was adequate time to review them prior to the meeting. Ms. Briggs stated the lease would be written from July 18, 2000 to July 2003. They are still waiting for the Mesa Mall people to approve the new lease. The current lease expires on August 31, 2000.

Mr. Shaver asked the applicant if all the requested documents have been submitted at this time except for the new lease. Ms. Briggs stated yes. Mr. Shaver recommended continuing this matter to the next hearing date with the understanding that if there is not a lease, and the requested documents are not adequate, there will be no license approved at that time.

VII. APPLICATION FOR SPECIAL EVENTS PERMIT

1. Grand Junction Air Show, Incorporated for a 3.2% Fermented Malt Beverage Special Events Permit for the "Grand Junction Airshow" on September 9 and 10, 2000 from 10:00 a.m. to 7:00 p.m. at Walker Field Airport, 2828 Walker Field Drive
