MINUTES

WEDNESDAY, NOVEMBER 1, 2000, 9:00 A.M.

- I. **CALL TO ORDER** – The meeting was convened at 9:00 a.m. Those present were Hearing Officer Phil Coebergh and City Clerk Stephanie Nye. Assistant City Attorney John Shaver was not present.

- II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**
 1. JEMSKT Incorporated dba Ranch Liquors, 2314 Highway 6 & 50, Retail Liquor Store

Marty Denton, owner, was present. The application was in order and approved.

 2. JESST Incorporated dba Wrigley Field, 1810 North Avenue, Hotel and Restaurant

The application was in order. The Police report showed some calls were made to the establishment address. The application was approved contingent upon a favorable Police report being filed.

 3. ACE Ventures Incorporated dba Pancho's Villa, 801 North 1st Street, Hotel and Restaurant

The application was in order. The Police report indicated there was a case of beer stolen from the rear of the establishment. The application was approved.

 4. Buon Appetito Incorporated dba il Bistro Italiano, 400 Main Street, Hotel and Restaurant

Brunella Gualerzi, owner, was present. The application was in order. The Police report indicated they had been called to this location for several incidents. Ms. Gualerzi stated they did not have any problems at the establishment. There were 2 calls from the establishment-one involved a theft of \$20 from a customer and one was to report an accident that happened at the corner of Main and 4th Street. The other calls were made for incidents that happened outside the establishment. The application was approved.

 5. P & S Incorporated dba Orchard Mesa Lanes, 295 27 Road, Hotel and Restaurant

The application was in order and approved.

 6. Restaurant Concepts II, LLC dba Applebee's Neighborhood Grill & Bar, 711 Horizon Drive, Hotel and Restaurant

Brad Willms, the general manager, was present. The application was in order and approved.
