I. <u>CALL TO ORDER</u> – The meeting convened at 9:04 a.m. Those present were Alternate Hearing Officer James Majors, Assistant City Attorney John Shaver and Senior Administrative Assistant Christine English.

II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

- 1. Dillon Companies Incorporated dba City Market, **3 Locations**, 3.2% Beer Off Premise
 - A. City Market #1, 2770 Highway 50 South
 - B. City Market #9, 1909 North 1st Street
 - C. City Market #32, 200 Rood Avenue

Doug Randall, manager of City Market #1, was present representing all 3 City Market stores. The applications were in order and approved.

2. Fishers Liquor Barn Incorporated dba Fishers Liquor Barn, 2438 F Road, Retail Liquor Store with Delivery Permit

The application was in order and approved.

3. Grand Junction North Avenue Liquors Incorporated dba North Avenue Liquor, 801 North Avenue, Retail Liquor Store with Delivery Permit

The application was in order and approved.

4. Dos Incorporated dba Dos Hombres Restaurant, 421 Brach Drive, Hotel and Restaurant

The applicant did submit a letter of explanation on the cause for late filing (see attached). Mr. Majors admonished the applicant to file the renewal in a timely manner in the future. The application was in order and approved.

IV. APPLICATION FOR RENEWAL AND MODIFICATION OF PREMISES

 Dillon Companies Incorporated dba City Market #18, 2830 North Avenue, 3.2% Beer Off Premise

Interior remodel of the store. Beer will be licensed at 28 linear feet. Begin July 7, 2001; end September 12, 2001.

Pat Mora was present representing City Market #18. Mr. Mora stated the store would be closing during the remodel and no sales will take place. The applications were in order and approved.

V. <u>APPLICATION FOR MODIFICATION OF PREMISES</u>

Modern World Cabaret LLC dba The Cabaret, 701 Main Street, Tavern

Remove current bar to accommodate more seating and begin serving from the existing bar at Greenfield's (such premises now leased by Modern World Cabaret, LLC)

Kevin McConnell was present representing Modern World Cabaret. The application was in order and approved subject to the issuance of building permits by the Mesa County Building Department.

Scott Dvorak was present. The application was in order. The building is undergoing a remodel at this time and final inspections have not been completed. A Certificate of Occupancy will need to be filed prior to the issuance of the license. Mr. Dvorak stated the Holiday Inn, who will cease operations on July 22, 2001, is still operating the kitchen. The form will be completed regarding the transfer of inventory will be completed and filed in the City Clerk's office by next week.

Ms. English asked if it were necessary for the applicant to file for a temporary permit if the application is approved today. Mr. Shaver stated yes. The way the lease is written, it states upon completion of the remodel and upon issuance of the Certificate of Occupancy, is when Coco's will take over operations. They will need to file for a temporary permit at that time. If Coco's will be taking over operations prior to the issuance of the Certificate of Occupancy, they will need to file for a temporary permit.

Mr. Dvorak stated he will have a training team coming in on July 29, and will need to have access to the bar at that time. The Certificate of Occupancy should be issued by July 27th or 28th. The projected opening day for Coco's is August 6, 2001.

There was no one present in opposition to the transfer. The application was approved.
