- 21. General architectural description: This is a simple wood frame house with a low pitched hipped roof. The main hipped roof form has a short ridge that runs east/west and the principal facade faces south. A lower hipped roof form projects from the west side and runs over half the width of the facade. A small double hung window sits on the face of the projecting volume, centered between the west corner and a deep recess at the right. The main entry is set in the narrow recess and the main wall plane continues for a short distance on the far side of the door. A large picture window is located on the wall of the main volume. The picture unit is flanked by narrow double hungs to each side. The flat roofed carport extends off the east side, continuing the eave line of the main hipped roof. The flat roof is supported by four thin columns on the east side. Two double hungs sit on the east wall near the center below the carport roof. The west wall has two double hungs evenly spaced along the length of the wall. A shed roof extends off the rear of the house.

- 23. Landscaping or special setting features: Two large street trees sit along the front of the lot and the driveway runs to the carport on the east. Several shrubs run along the property line, otherwise the yard is predominantly lawn.

- 42. Statement of significance: <u>The development in this area is a direct result of the nation's involvement in WWII and the drive for the development of nuclear weapons. The discovery of significant sources of Uranium in the region initiated development in Grand Junction that supported both the mining of the materials and the administration of programs related to the development of weapons. The building types, materials and neighborhood layout are all indicative of the national trends which were driven by the proliferation of the automobile and the enormous demand for single family homes. House designs departed from the romantic and revival styles that were prevalent in the earlier part of the 20th century and took on a California inspired design that was characterized by simple horizontally proportioned forms. Houses were typically mass produced on previously undeveloped tracts of land at the periphery of earlier.</u>

These groups of houses were typically based on one or two plan types. with a limited number of roof and exterior finish variations, further reinforcing the characteristics of mass production. In this particular subdivision there are examples of both repetitive house types and more high style individualized houses. The curvilinear street layout is characteristic of national planning trends and is unusual in this community, where new development tended to extend the existing street grid.

43. Assessment of historic physical integrity related to significance: <u>Alterations have</u> somewhat impacted the integrity of the house. Siding and window replacement are in keeping with the original character. The house continues to contribute to the character of the neighborhood.

Yes X No Discuss: The Bookcliff Park Subdivision lies on the periphery of the historic city center and was originally established by single group of investors. The sites were built out to accommodate the rapid growth associated with the Uranium Boom over a short period of time. The architectural styles present in the area represent a significant concentration and continuity of dwellings and a subtle transition of styles over the building period. Few intrusions have been made into the original neighborhood and it retains a high level of integrity.

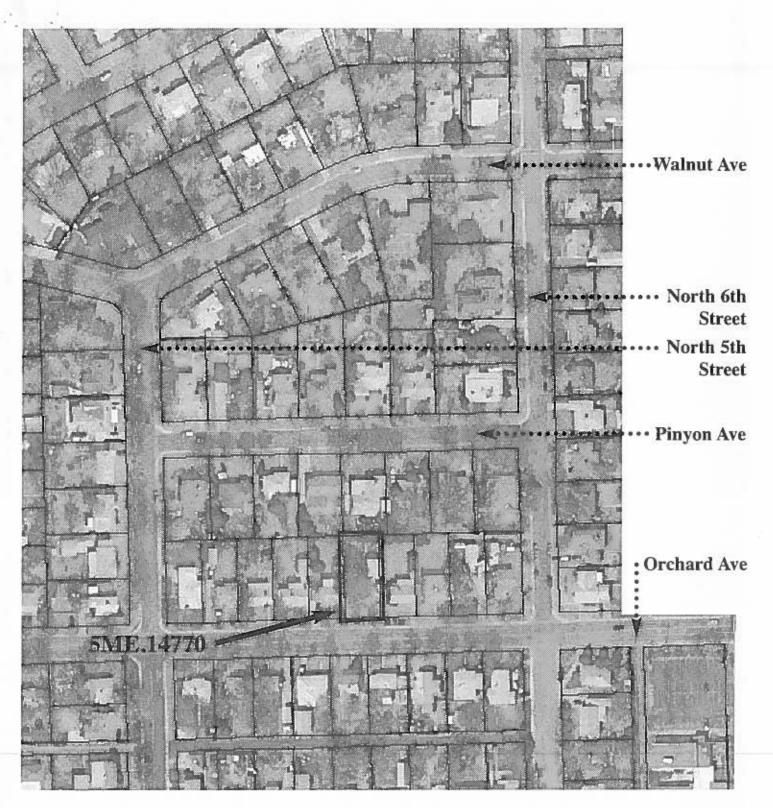

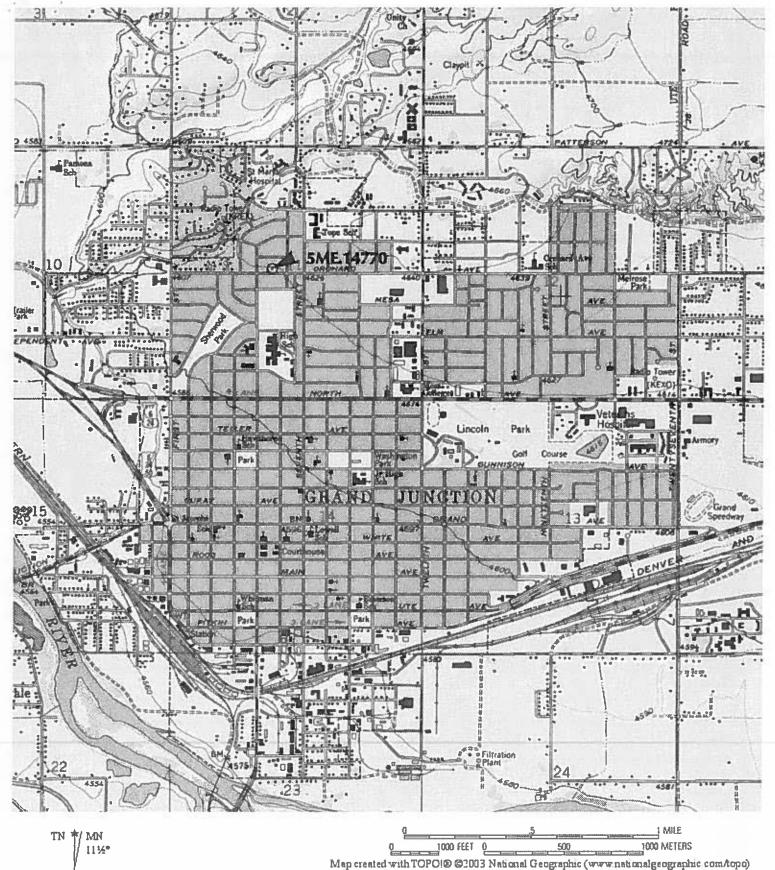
