#### MINUTES

### WEDNESDAY, April 17, 2002, 9:00 A.M.

I. <u>CALL TO ORDER</u> – The meeting convened at 9:02 a.m. Those present were Hearing Office Phil Coebergh, Assistant City Attorney John Shaver and Deputy City Clerk Juanita Wesley.

# II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

The application was found to be in order and approved.

Mr. Mike Archeleta was present representing the Latin Anglo Alliance Foundation.

Mr. Coebergh asked if there weren't any other facilities in Grand Junction to hold this event. Mr. Archeleta stated this is the 20<sup>th</sup> Annual Cinco de Mayo Celebration and it has always been held at this location. There was no opposition present. The application was found to be in order and approved.

# V. REVIEW OF STIPULATION AND AGREEMENT

1. In the Matter of Wigout Productions Inc., dba Mesa Theater and Club, 538 Main Street, Tayern

Review of Stipulation and Agreement entered into on August 2001 between the Local Licensing Authority and Wigout Productions Inc., dba Mesa Theater and Club

Mr. David Prather and Ms. Stephanie Rubenstein brought in and signed the revised stipulation. Ms. Rubenstein mentioned the proposed revision with a 3 month review has been changed to October 16<sup>th</sup>. The other revisions to the stipulation is to limit the amount of attendees to 350 for "college nights". Publication for "the event" known as "college

night" will be advertised with their regular calendar of events since the college radio goes on satellite on May 10<sup>th</sup> and the "Criterion" isn't published again until next semester. Barricades will be used to keep the people moving when the event is over; there will be more security on those nights provided by additional staff of Mesa Theater. They will stop serving liquor at 1:30 a.m.

Mr. Shaver stated it was not easy to define all the circumstances that could occur. Mr. Coebergh stated he believed that the stipulation is full of holes, but the license could be reviewed at any time by the authority.

With the stipulation signed and these items agreed upon, Mr. Coebergh approved the stipulation with the review date of October 16, 2002.
