#### V. RESOLUTION OF FINDINGS AND DECISION RE: APPLICATION FOR NEW LICENSE

Chester L. Allen and Janet Gardner, dba Boomers, 436 Main Street, Tavern

Both Mr. Allen and Ms. Gardner were present. Ms. Wesley read into the record the results of the survey (see attached). Mr. Shaver questioned Mr. Allen concerning the survey, who conducted it, the time of day and if the results read into the record were true and accurate. Mr. Allen stated he personally conducted the survey. Mr. Allen stated the results read into the record were true and accurate. Ms. Wesley read a letter from Mesa County Health Department that the Plan Review Application is not complete. Mr. Allen stated he was still working with Mesa County on that regarding the kitchen facilities.

Mr. Majors asked if there was anyone present in opposition. Mr. William Keith came forward from 443 Main Street, the Quilt Shop. Mr. Keith stated he was not a participant in the survey, but was in opposition of another business like Mr. Allen's in the area of  $1^{st} - 7^{th}$  Streets. Mr. Keith has received vandalism, defacing of property and the use of the public parking right behind his building; they pick up beer bottles and trash each day. They conduct classes in the evenings with the primary attendees being elderly female. He is concerned about the crowd that another establishment will bring in.

Mr. Allen addressed Mr. Keith's concerns regarding this issue. Mr. Allen's hope by the name "Boomers" that they appeal to the "baby boomers" an older more mature crowd and Mr. Keith would not see an increase in any destruction.

Mr. Majors stated the survey does meet the statutory criteria and Mr. Shaver concurred. A resolution of findings and approval will be prepared once the additional issues with Mesa County Health Department are finalized and the City Clerk's Office is notified.
