II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

1. Inafuku, Inc. dba Suehiro Japanese Restaurant, 541 Main St., Hotel/Restaurant

The application was found to be in order and approved.

2. Fisher Liquor Barn Inc., dba Fishers Liquor Barn, 2438 F Road, Retail Liquor Store

The application was found to be in order and approved.

III. **APPLICATION TO REGISTER MANAGER**

1. GMRI, Inc. dba The Olive Garden Italian Restaurant #1580, 2416 Hwy. 6 & 50, Hotel/Restaurant

No one was present. Ms. Wesley did state that the new manager would be an onsite manager and has recently moved to the area.

The manager registration was approved.

IV. **APPLICATION FOR A SPECIAL EVENTS PERMIT**

1. Application by Western Colorado Congress for a Malt, Vinous and Spirituous Liquor Special Events Permit for Fundraiser for Reception in the Bookcliff Café, Mesa State College Center on September 21, 2002 from 6:00 p.m. to 8:00 p.m.

Applicant: Western Colorado Congress, PO Box 472, Montrose, CO 81402

Ms. Amy McBride was present as the Event Coordinator.

Mr. Shaver asked if the reception was open to the public and if there was a cost associated. Ms. McBride stated the reception is open to the public and is a book signing and there is a cost associated. Ms. McBride stated they contacted two other facilities, the Adams Mark and Two Rivers Convention Center. The Adams Mark was booked on that day and Two Rivers Convention Center was booked except for two larger rooms. Ms. McBride also stated that Mesa State has an official sanctioned club related to them that it is easier for them to host everything under one roof (Mesa State College).

Mr. Shaver was satisfied that the statutory requirements have been met. There was no opposition present. Ms. Wesley reported that there is an issue regarding their sales tax that they must clear up. The application was found to be in order and approved based on

the sales tax issue being cleared up. (This was cleared up right after the meeting as per the City's sales tax division).

2. Grand Junction Airshow Inc. for a Fermented Malt Beverage Special Events Permit for an Air Show on September 20, 2002 from 6:00 p.m. to 10:00 p.m. and on September 21, 2002 from 8:00 a.m. to 4:00 p.m.

Applicant: Grand Junction Airshow Inc., 1425 Hall, Grand Junction, CO 81501

Ms. Peg Wallace was present representing Grand Junction Airshow Inc. Ms. Wallace stated that they expect 25,000 people in attendance of this event. The capacity of the restaurant at the Airport is less than 50 people with the added security at Walker Field since September 11, 2001 it is very difficult to detour people through the airport and this event will be outside.

Mr. Shaver was satisfied that the statutory requirements have been met. There was no opposition present. The application was found to be in order and approved.

V. APPLICATION TO CHANGE TRADE NAME

1. Thomas L. Goerke dba C & D Food Store, 2685 Unaweep Avenue, 3.2% Beer License (Off Premises)

Change of Trade Name from C & D Food Store to Andy's Food Store.

Mr. Goerke was present. Mr. Goerke said he has always been confused with C&F Food Stores so it was time for a name change.

The application was found to be in order and approved.
